In review of the documentation that was submitted if this is within a County ROW we do not see any issues with this location and design of the sign. With the distance and elevation it does not appear to be a hazard within the ROW.

However, the applicant will want to make sure that this does not fall within a UDOT ROW, and if it does they will need to be contacted and their process followed.

If it does fall within a County ROW the applicant will need to be aware that in the future any road improvements may require the sign to be relocated.

Please disregard the original request for the Monument sign, (#1) on the application. We would like to instead put a guidance sign at this location. The guidance sign will be 8 feet wide and 9 feet tall. It will be installed in a log and masonry frame that is 18 feet high and 12 feet wide. There will be no lighting and natural landscaping. The sign location is marked with a purple dot beside the #1 on the sign location plot. The nearest corner of the sign would be 40 feet from the edge of the asphalt east of Snowbasin road on a 5 foot high natural terraced area. This puts it 60 feet from the centerline. I have attached the concept drawing, an engineered plan, photos of the perspective from the road and an overview of the layout.
