NORTH FORK OF THE WEBER RIVER IS THE CLOSEST DRAINAGE, APPROX. 250 FT FROM


STORM WATER CURRENTLY RUNS TO THE SOUTH SOUTH EAST TO EPHEMERAL STREAM












LANDSCAPING PLAN LPC LOMONDI WELL 6649 N NORTH FORK RD.
