URPOSE OF RESOLVING A NON-CONFORMING PARCEL AS RECORDED IN THE OFFICE OF THE WEBER COUNTY RECORDER'S. THE BASIS OF BEARINGS IS STATE PLANE GRID PER WEBER COUNTY NORTH 89"39'42" WEST 2634.62 FEET BETWEEN THE BRASS CAPS FOUND MARKING THE NORTH QUARTER CORNER OF SECTION 29 AND THE NORTHEAST CORNER OF SECTION 29, OWNSHIP 7 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN. LOT CORNERS HAVE BEEN MONUMENTED AS DEPICTED ON THIS PLAT.





BEGINNING AT A POINT ON THE EAST LINE OF LOT 13 LIBERTY MEADOWS SUBDIVISION, AS RECORDED IN THE WEBER COUNTY RECORDERS OFFICE, SAID POINT BEING NORTH 89°39'42" WEST 590.50 FEET ALONG THE SOUTH LINE OF SAID SECTION 20. AND SOUTH 07°35'03" WEST 17.18 FEET ALONG SAID EAST LINE OF LOT 13 FROM THE NORTH EAST CORNER OF SAID SECTION 29; RUNNING THENCE NORTH 89°39'42" WEST 150.32 FEET TO THE WEST LINE OF SAID LOT 13; THENCE NORTH 00°18'18" EAST 568.96 FEET ALONG SAID WEST LINE OF LOT 13 TO THE SOUTH RIGHT-OF-WAY LINE OF 3600 NORTH STREET; THENCE SOUTH 89°41'42" EAST 318.02 FEET ALONG SAID SOUTH RIGHT-OF-WAY LINE AND THE EXTENSION THEREOF; THENCE THE FOLLOWING FOUR (4) COURSES AND DISTANCES; (1) SOUTH 08°13'14" EAST 269.81 FEET; (2) SOUTH 40°09'15" WEST 210.68 FEET; (3) NORTH 89°41'42" WEST 54.75 FEET TO THE EAST LINE OF SAID LOT 13; (4) SOUTH 07°35'03" WEST 141.61 FEET TO THE POINT OF BEGINNING.

WE, THE UNDERSIGNED OWNERS OF THE HEREIN DESCRIBED TRACT OF LAND DO HEREBY SET APART AND SUBDIVIDE THE SAME INTO LOTS AS SHOWN ON THE PLAT AND NAME SAID TRACT LIBERTY MEADOWS SUBDIVISION 2ND AMENDMENT, AND DO HEREBY GRANT AND CONVEY TO WEBER COUNTY, UTAH, A PERPETUAL RIGHT AND EASEMENT OVER, UPON AND UNDER ALL THOSE PARTS OR PORTIONS OF SAID TRACT OF LAND DESIGNATED AS EASEMENTS, THE SAME TO BE USED FOR PUBLIC UTILITY, DRAINAGE AND INGRESS EGRESS PURPOSES AS SHOWN HEREON, THE SAME TO BE USED FOR THE INSTALLATION, MAINTENANCE AND OPERATION OF PUBLIC UTILITY SERVICE LINES AND DRAINAGE, AS MAY BE AUTHORIZED BY WEBER COUNTY.
