Kelli,

Thank you for your response. The work that will occur on NFS land is as follows:

The dirt road to access the reservoir site crosses onto NFS land for 140 feet. As part of the construction this road will be graded and widened to allow access for construction vehicles. This will include grading the existing road with a road grader and placing and compacting granular fill or roadbase material to widen the road as necessary. The existing roadway is 10 feet wide in most places and will be widened to 12 feet wide as part of the project. The bend in the road that is on NFS land will need to be wider than that in order to make the turn as shown on the plans. The total area on NFS land that will be affected as part of this grading will be 2,000 square feet (0.046 acres).

The Contractor will also replace the existing 8" waterline and underground power cable with a new 10" waterline and 2-1/2" electrical conduit. These utilities will be installed in the access road so there will be 140 feet of both of these utilities on NFS land. As I mentioned, this work will be just to replace existing lines that are already located on NFS land.

The new reservoir will be constructed on land owned by the Uintah Highlands Improvement District and a new 6' security fence will be installed around the site. This fence will be on the property line with NFS land for 80 feet.

Kelli,

Attached are the plans for the Culinary Water Reservoir Rebuild that we are submitting on behalf of Uintah Highlands Improvement District. I have also attached the geotechnical report. As we have discussed previously, the project is located on land owned by the Uintah Highlands Improvement District but the access road to the site crosses onto U.S. Forest Service property. The access road has been there since the original tank was built around 40 years ago. The scope of this project is to remove the existing tank completely and build a new circular concrete reservoir in the same location.

Construction of the project is anticipated to begin in May or June 2015 and be completed by the end of September 2015. During this time construction vehicles and machinery will use the road to access the site and the road will be graded and widened accordingly to allow for the access. Reservoir construction will occur on property owned by the District and any impact to Forest Service land will be kept to a minimum. Utilities in the access road will also be replaced. After the construction is completed the District will continue to use the access road periodically (at least once monthly) for routine maintenance on the reservoir. Currently the only use of the road is for access to the reservoir and there is a locked gate near Jacqueline Drive restricting access.
