
Comments

Any outdoor lighting must comply with section 108-16 of the land use code. Per 15A-1-204(11)(B) of Utah state code, this parcel qualifies for the Agriculture Exemption as it is 2 contiguous acres in a subdivision that will be used for agriculture. There is a 10ft PUE on the front lot line and the side lot line facing 2950 E. Approval is conditional on the District and the Building Official's review.
