CHAS. EMPEY and Katie Empey his wife and the Estate of E.C.OLSEN, deceased, by Harold E.Olsen, Adm. Grantors of Weber County, Utah, hereby convey and warrant to Utah Power & Light Company a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 2 guy anchors & 3 poles, with the necessary guys, stubs, cross arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor in Weber County, Utah, along a line described as follows: Beg. at present pole on grantors land at a point 700 ft. north and 1530 ft. west, more or less, from the east quarter corner of Sec. 1. T. 7 N., R. 1 W., S.L.B. & M. th. running N. 53°12' W 306 ft. th N. 82°12' W 351 ft. th N. 48°48' W. 600 ft., more or less, to west boundary line of said land and being in the Sw 1/2 of the NE 1/4 and Lot 2 of said Sec. 1. Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantees use occupation or enjoyment of this easement.
