A PART OF THE NORTH HALF OF SECTION 16, TOWNSHIP 6 NORTH RANGE 2 EAST OF THE SALT LAKE BASE AND MERIDIAN. 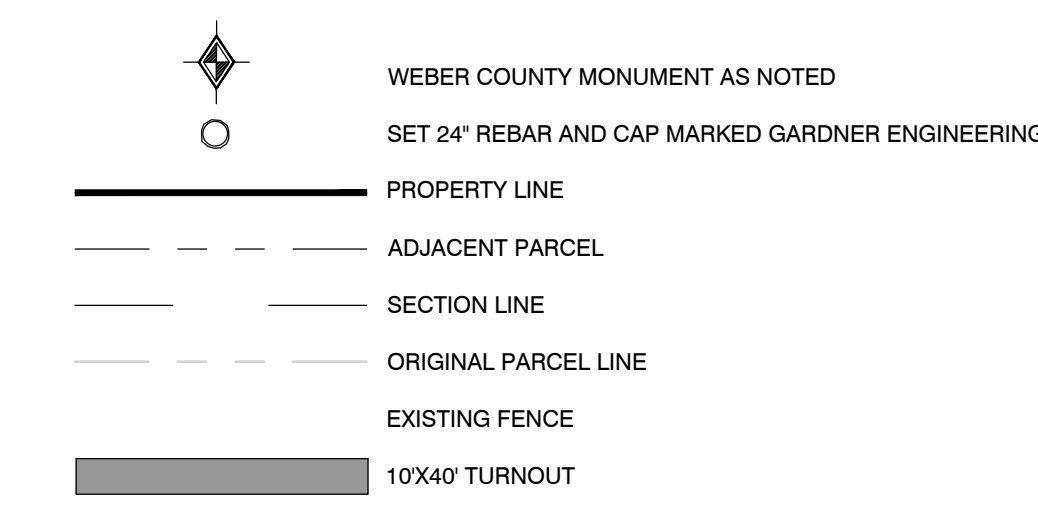

**NARRATIVE:**

THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION SURROUNDING SECTION 16, TOWNSHIP 6 NORTH, RANGE 2 EAST OF THE SALT LAKE BASE AND MERIDIAN AS SHOWN AND NOTED HEREON. FENCE LINES AND RECORD OF SURVEY NUMBER 3342 RECORDED IN OCTOBER OF 2004 WAS RELIED UPON FOR THE EXTERIOR BOUNDARY LINES OF THE PROPERTY DESCRIBED IN WARRANTY DEED RECORDED AS ENTRY NUMBER 2817154. INTERIOR BOUNDARY LINES ARE BASED ON INSTRUCTION FROM THE CLIENT. THE BASIS OF BEARING IS THE EAST LINE OF THE NORTHEAST QUARTER OF SECTION 16, TOWNSHIP 6 NORTH, RANGE 2 EAST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 00°14'22" EAST WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING.

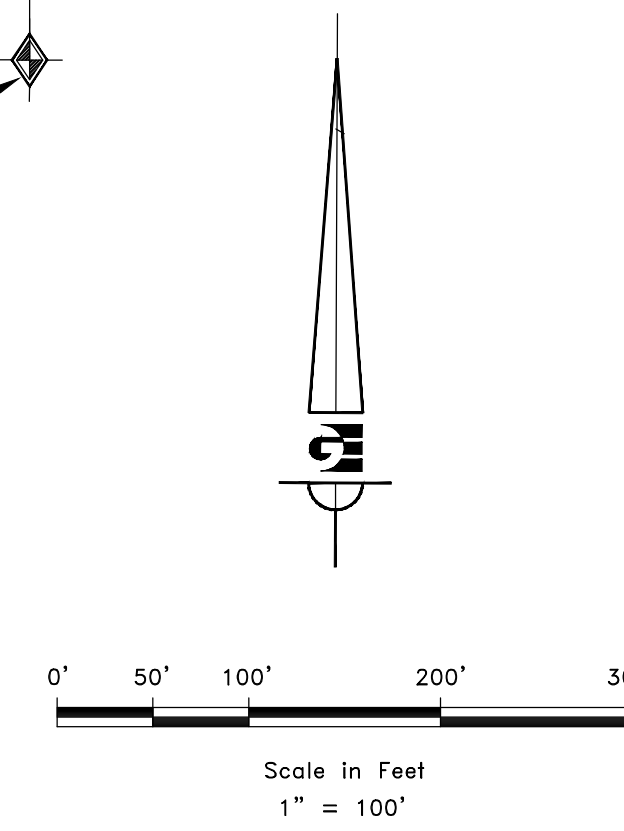
