

Thank You for submitting plans for a Meat Cutting Shop, located in Liberty, Utah. I have completed a review of the plans as submitted.

A review of the plans received, revealed no apparent violations with the **FDA 2005 Food Code, Chapter 6, Physical Facilities**. However, at least one on-site inspection with the general contractor throughout the construction process is encouraged.

This approval does not constitute approval of a Utah Department of Agriculture and Food permit to operate a food establishment. Registration of this facility with UDAF Division of Regulatory Services is encouraged as soon as possible.
