2.3 PUNCH LIST TIME



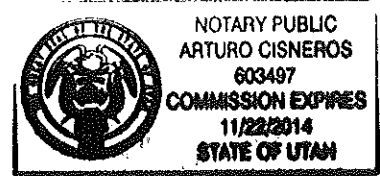


You are required to furnish the required CONTRACTOR'S Certificates of Insurance within ten (10) calendar days from the date of this Notice to you.
