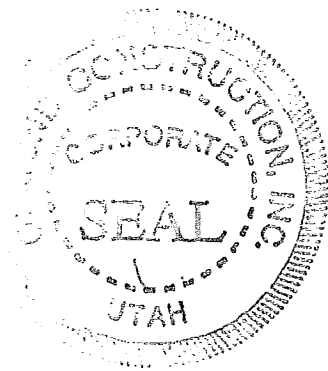

**3.3 PAYMENT**

- B. Quantities supplied or placed in the Work and measurements agreed to by CONTRACTOR determine payment.

### 3.4 BID ITEMS PAYMENT

#### A. **Remove Existing 36-inch CMP, Provide and Install 36-inch ADS N-12 Water-Tight Pipe, Complete; Bid Item No. 1**

1. Measurement and Payment by Linear Foot: 36 Inch culvert construction including but not limited to cost of mobilization, labor, equipment, materials, traffic control, safety; excavation, asphalt sawcut, disposal of excavated material and existing CMP and items incidental to prepare for 36 inch ADS pipe construction. Construction of ADS pipe MUST be installed per manufacturer's recommendations. Additional items of work include imported backfill, sub-base stabilization as needed, installing base course, fine grading, compaction, provide and compact base course fill between gutter and asphalt (no asphalt patching), restoration of public and private improvements resulting from work under this item.
2. Payment is based upon linear feet measured along the pipe.
