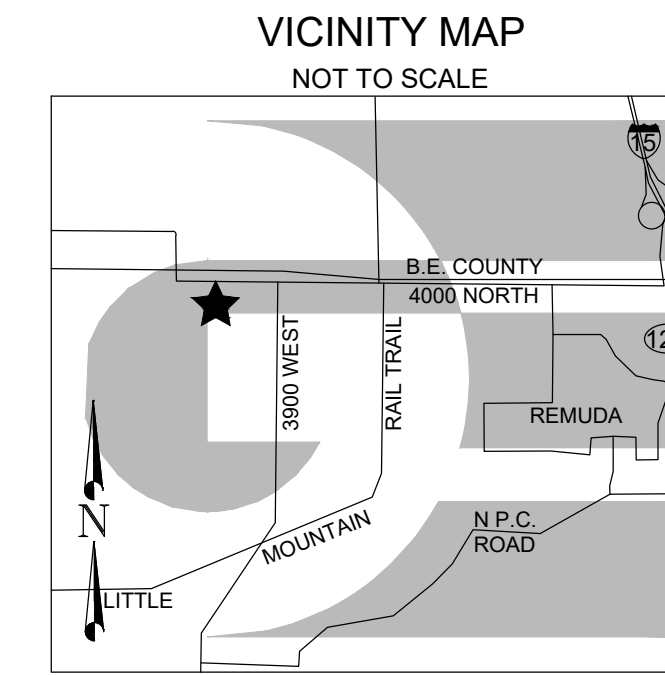

BOUNDARY DESCRIPTION

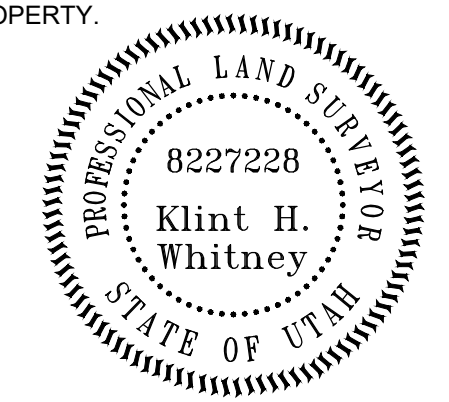
A PART OF THE NORTHWEST QUARTER OF SECTION 21, TOWNSHIP 7 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT ON THE NORTH LINE OF SAID NORTHWEST QUARTER, BEING LOCATED SOUTH 89°49'33" EAST 658.00 FEET ALONG SAID NORTH LINE FROM THE NORTHWEST CORNER OF SAID SECTION 21, RUNNING THENCE ALONG SAID NORTH LINE SOUTH 89°49'33" EAST 160.00 FEET; THENCE SOUTH 0°53'37" WEST 283.59 FEET; THENCE NORTH 89°49'37" WEST 159.34 FEET; THENCE NORTH 0°45'39" EAST 283.59 FEET TO THE POINT OF BEGINNING. CONTAINS 45,278 SQUARE FEET.

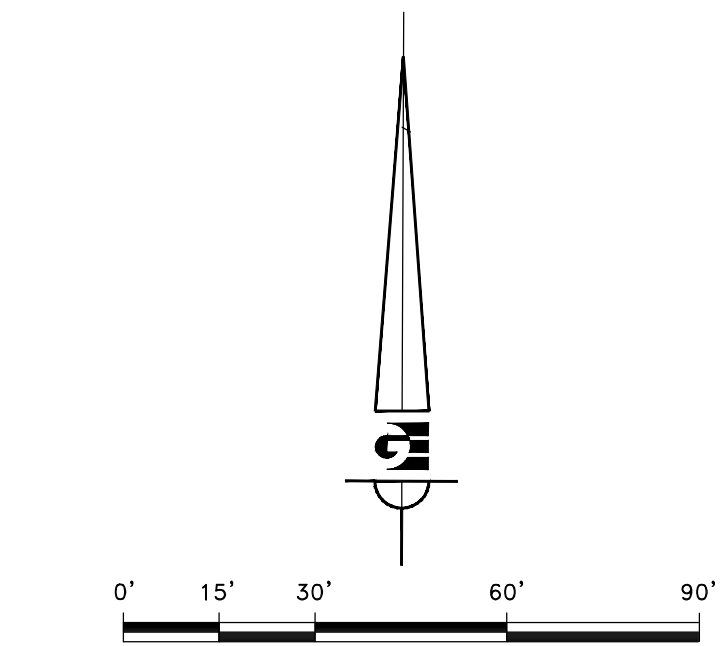

THE PURPOSE OF THIS SURVEY WAS TO CREATE A ONE LOT SUBDIVISION ON THE PROPERTY AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JEFF HALES. THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION AS SHOWN AND NOTED HEREON. THE BASIS OF BEARING IS THE NORTH LINE OF THE NORTHWEST QUARTER OF SECTION 21, TOWNSHIP 7 NORTH, RANGE 2 WEST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS SOUTH 89°30'43" EAST WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. THE RIGHT-OF-WAY OF 4000' STREET WAS ESTABLISHED BY HONORING THE PROJECTED RIGHT-OF-WAY DEDICATION OF THE LINDSAY ESTATES SUBDIVISION.

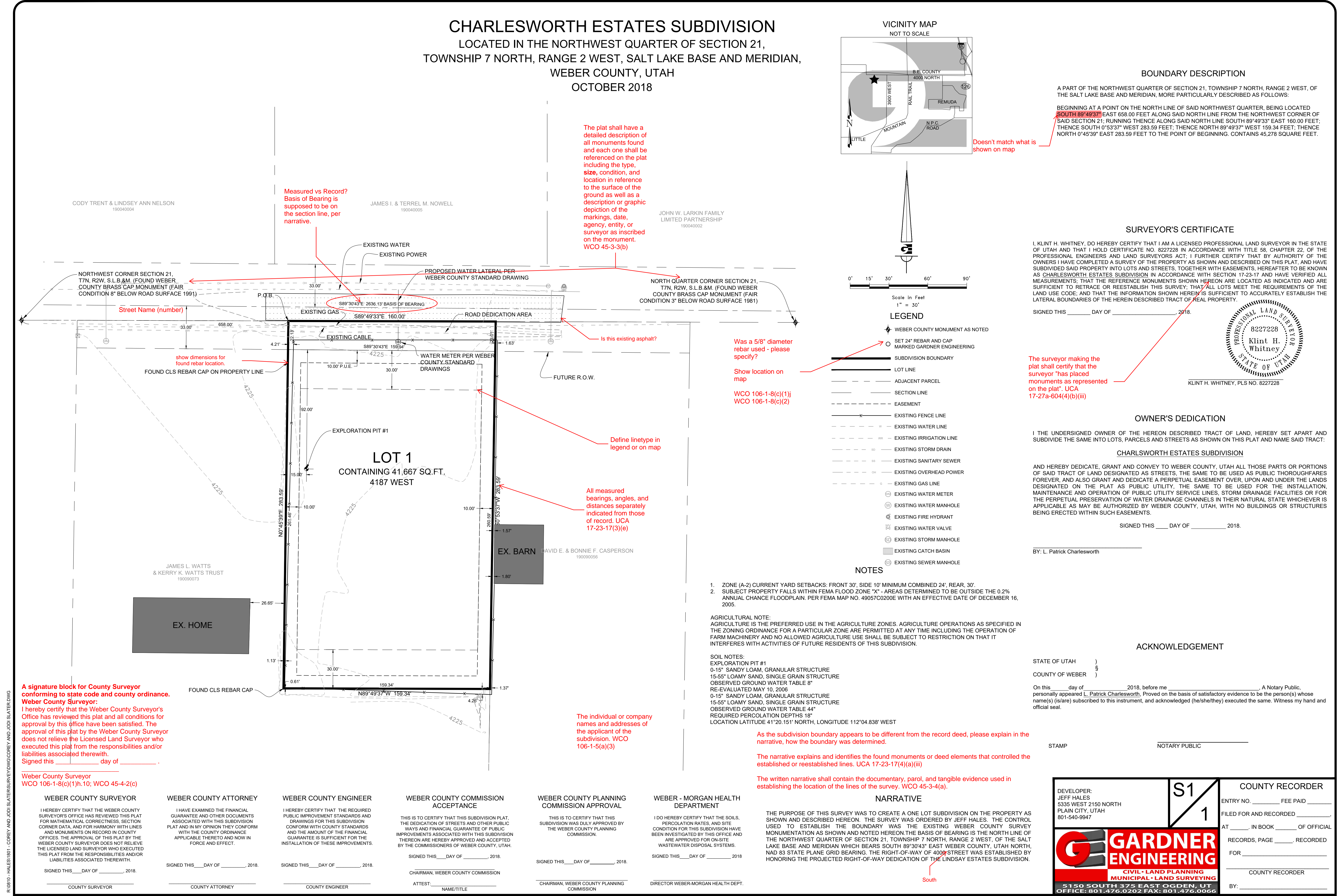
