Brandon,

The developer is required to pay 10% non-refundable deposit based on the number of connections rounded to a full connection. So for 8 lots the total infrastructure fee will be \$60,000 (i.e. \$7,500/Lot). Your non-refundable deposit will be \$7,500. You will be required to pay the balance of \$52,500 no later than one year of our signed agreement after which you/owner will be assessed a standby fee of \$20/month/lot until connected.

The developer is responsible for all costs required to modify our existing system to support your connection.

I believe the nearest connection point to your subdivision will be at the intersection of Panaroma Circle and Big Sky Drive.

In addition, each lot owner will be required to pay a one-time membership fee of \$300 each at the time they desire to connect to the system.

Assuming you are planning to develop at the south end of Big Sky Drive, please be aware, the pipeline along Big Sky Drive from Panaroma Circle will have to be upgraded to an 8" line in order to support your development at your cost. We are in the process of upgrading the line from 3500 East at Big Sky Drive to the aforementioned intersection to 8" line.

Any information given here is subject to the approval of the Board of Directors.
