NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO MARK THE PROPERTY ON THE GROUND. THE BOUNDARY LINES WERE IDENTIFIED BY DEED AND BY FIELD MEASUREMENTS TO MONUMENTS, IMPROVEMENTS AND APPARENT OCCUPATION LINES SHOWN HEREON. THE NORTH BOUNDARY LINE WAS DETERMINED BY MEASUREMENTS TO ROADWAY IMPROVEMENTS OF 4000 NORTH STREET AND AN EXISTING FENCE OF LONG RELIANCE CALLED OUT IN THE CURRENT DEED OF RECORD. THE SOUTHERLY BOUNDARY LINE WAS IDENTIFIED BY RETRACING THE DIAMOND H SUBDIVISION 1ST AMENDMENT, RECORDED AS ENTRY 2823322, BOOK 80, PAGE 04 IN THE OFFICE OF THE WEBER COUNTY RECORDER. THE WESTERLY BOUNDARY TO AN EXISTING FENCE OF LONG RELIANCE. THE WESTERLY BOUNDARY LINE WAS IDENTIFIED BY FIELD MEASUREMENTS TO A DITCH ("DRAIN" PER DEED LANGUAGE).
