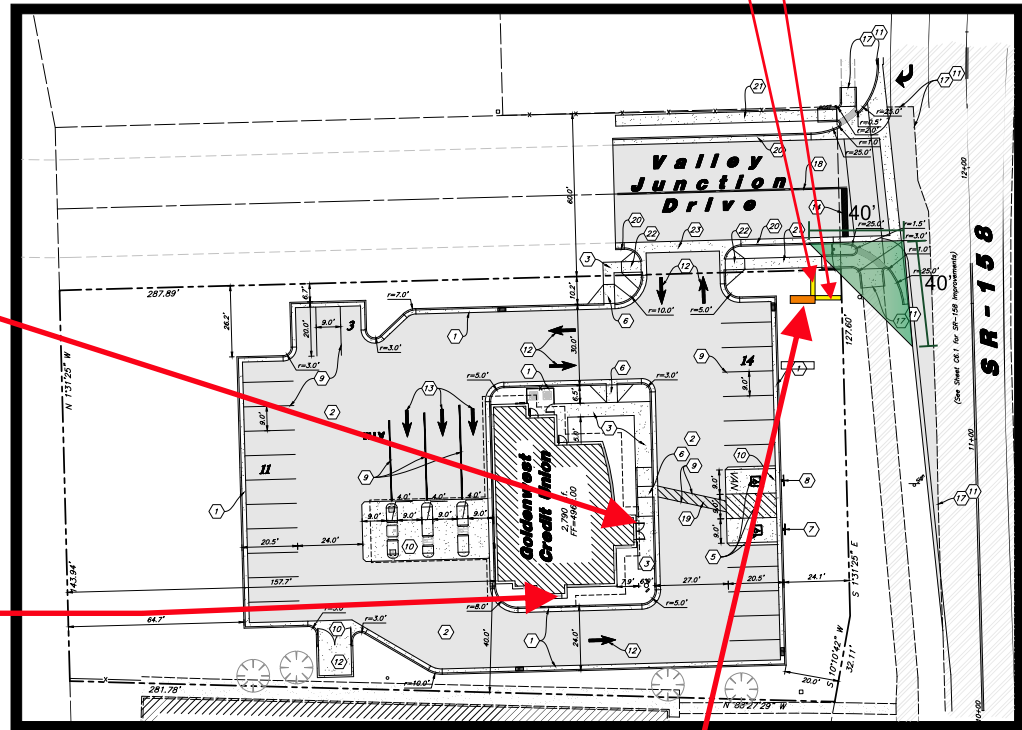
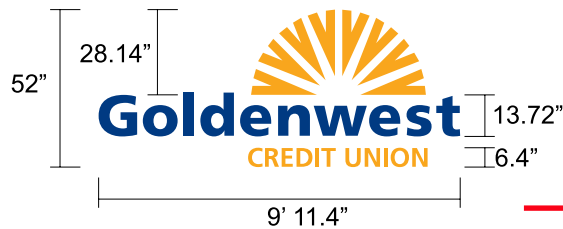

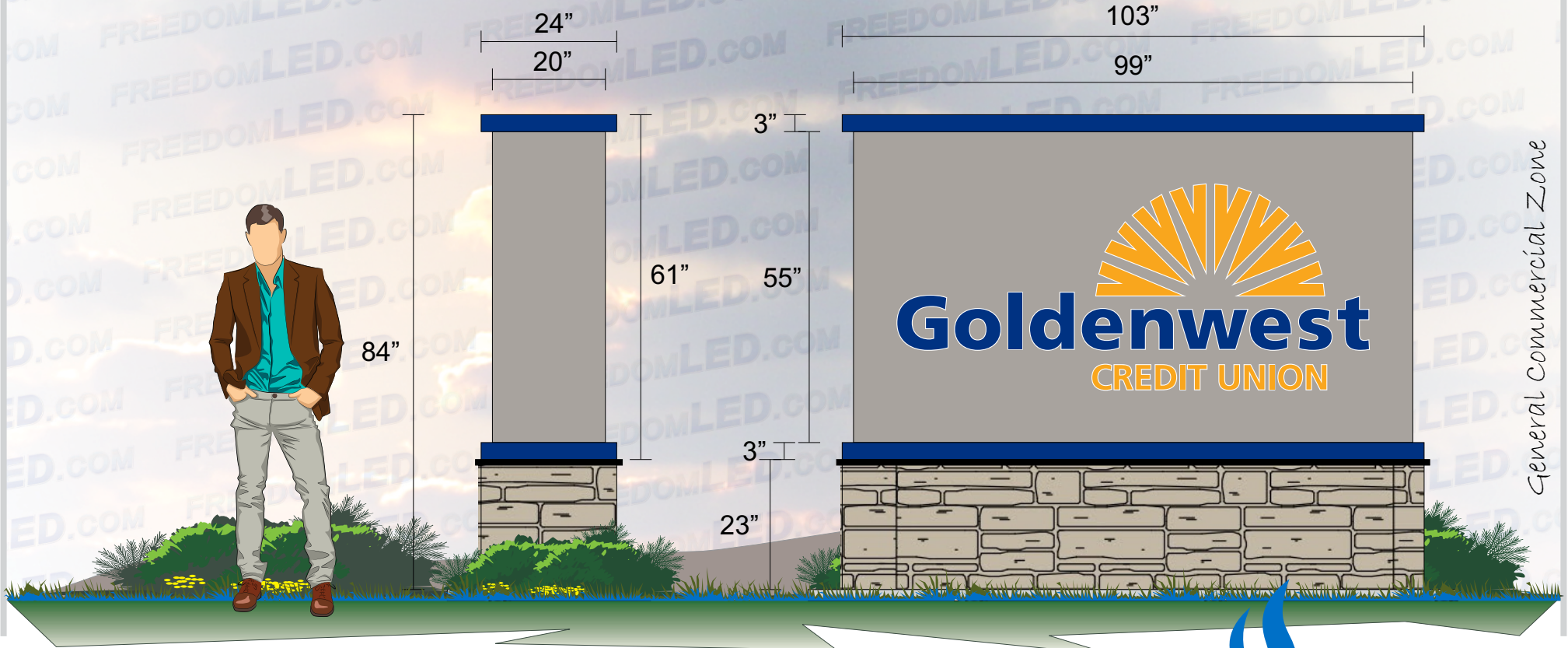

 Halo around the letters. faces will not light up.

COLOR now light earthy cream color to adhere to design standards (Dorian Gray SW 7017)

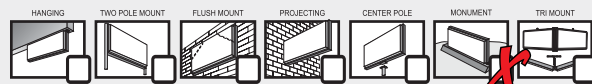
LED Lighting will be compliant with LUC 108-16-12
