
Comments

Sign Base will not be moving - only changing sign face to a single LED face. Applicant will have sign turned off from 10pm-6am. Until 10pm, sign will be lit at 30% of maximum so as to be minimally intrusive to any neighboring residential development. The pole will be re-painted a white, in the center of the pole, where the color already exists. The new sign cabinet will not exceed the current sign area in square footage. Sign print will not exceed 40% of the area of the sign cabinet.
