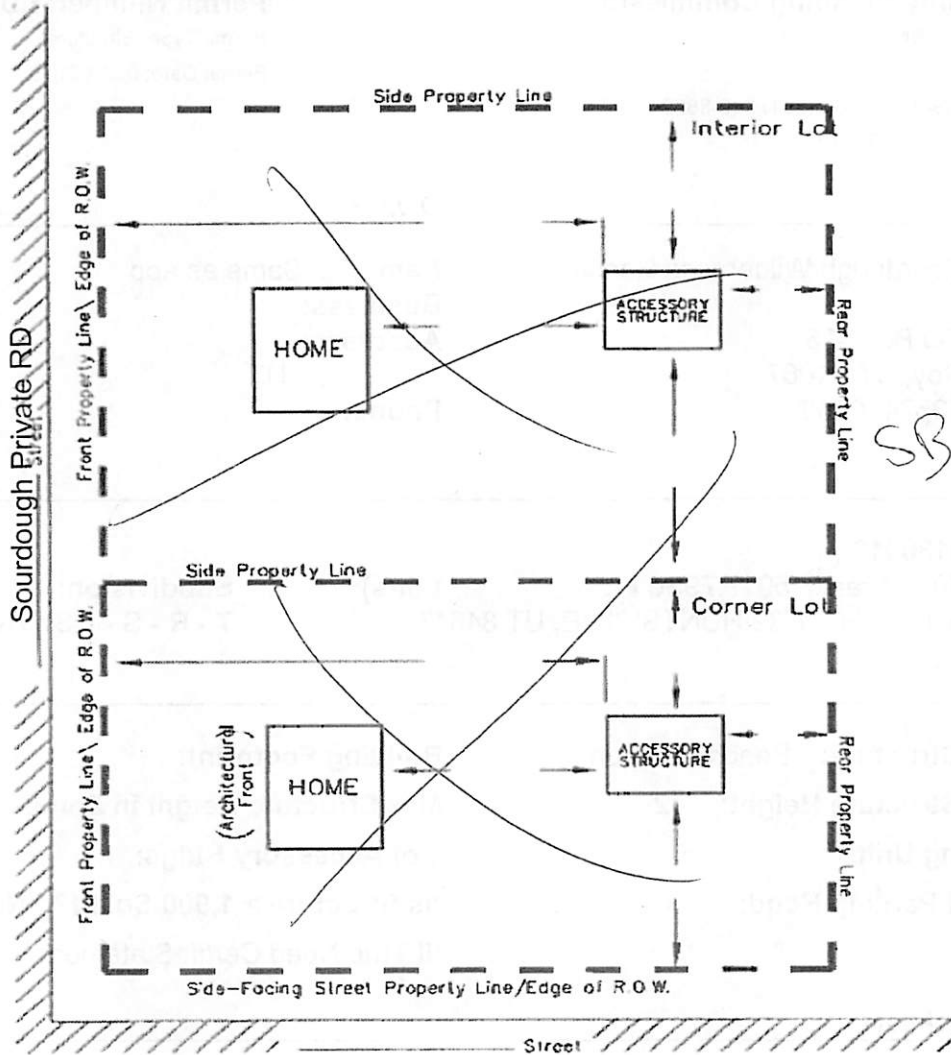
### Comments
