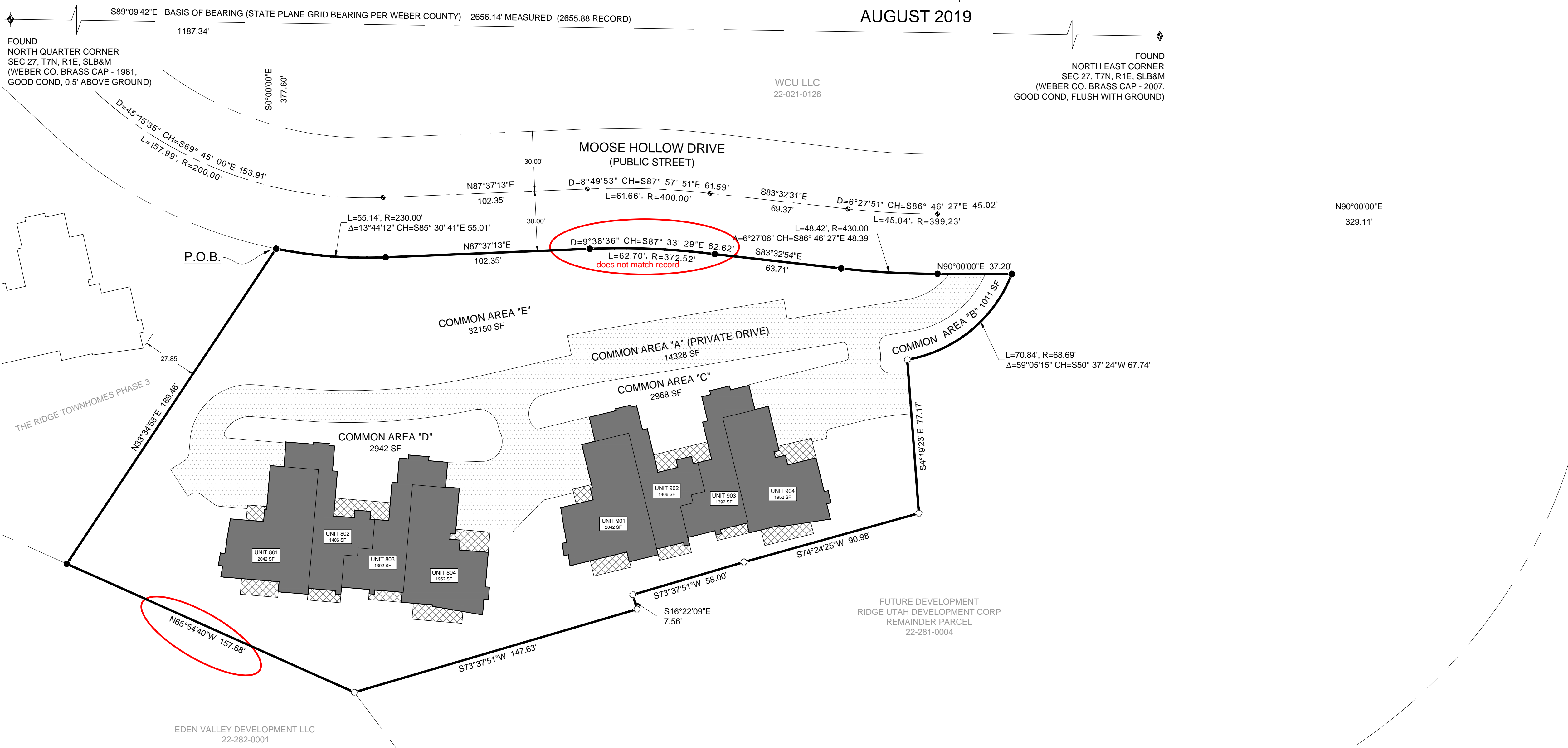

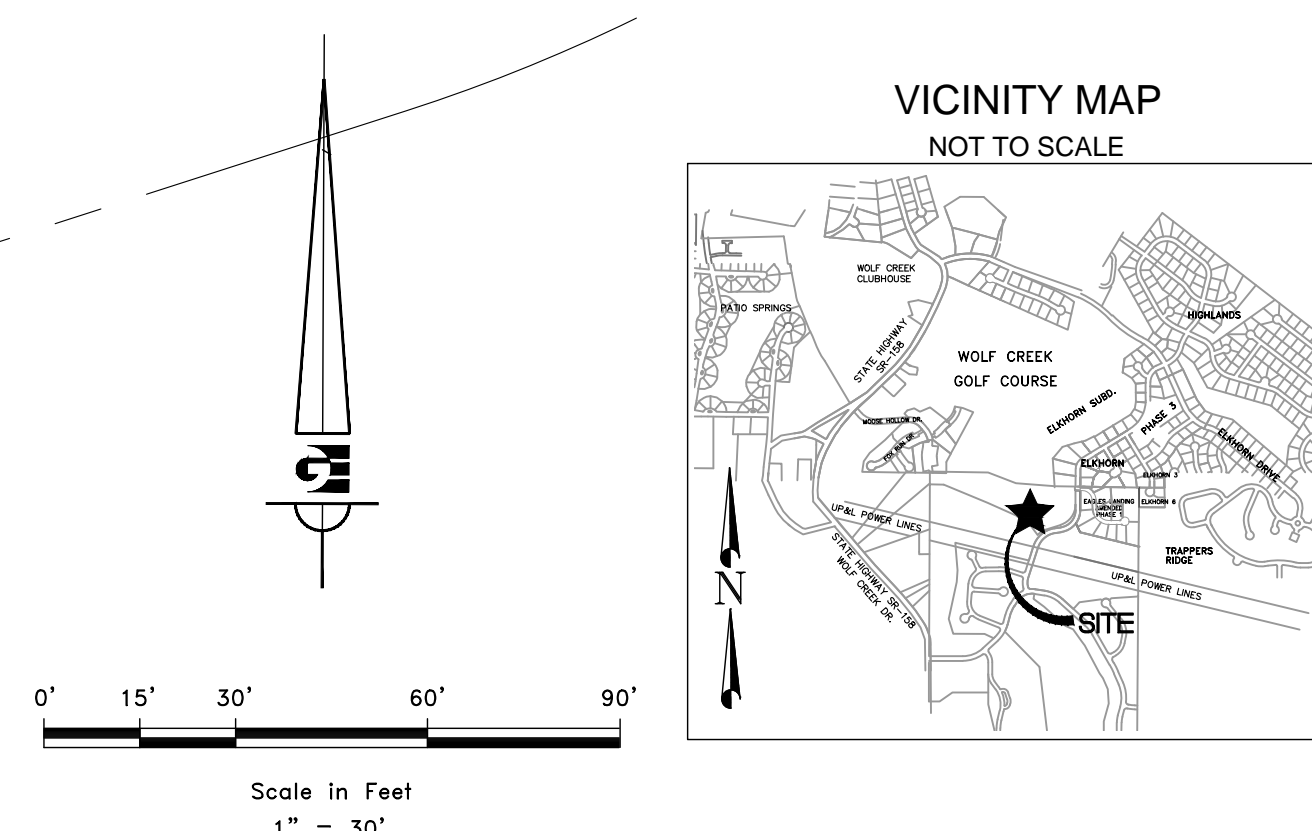

**NARRATIVE**

THE PURPOSE OF THIS SURVEY WAS TO CREATE A P.R.U.D SUBDIVISION PLAT AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JOHN L. LEWIS. THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION SURROUNDING SECTION 27, TOWNSHIP 7 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN. THE BASIS OF BEARING IS THE NORTH LINE OF THE NORTHEAST QUARTER OF SAID SECTION WHICH BEARS SOUTH 89°09'42" EAST 2656.14 FEET, WEBER COUNTY, NAD 83, STATE PLANE GRID BEARING, WARRANTY DEED RECORDED AS ENTRY #2684363 OF THE WEBER COUNTY RECORDS. DEDICATED PLATS FROM PREVIOUS PHASES OF THIS DEVELOPEMENT, AND FOUND REBAR AS SHOWN HEREON WERE USED TO DETERMINE THE BOUNDARY.

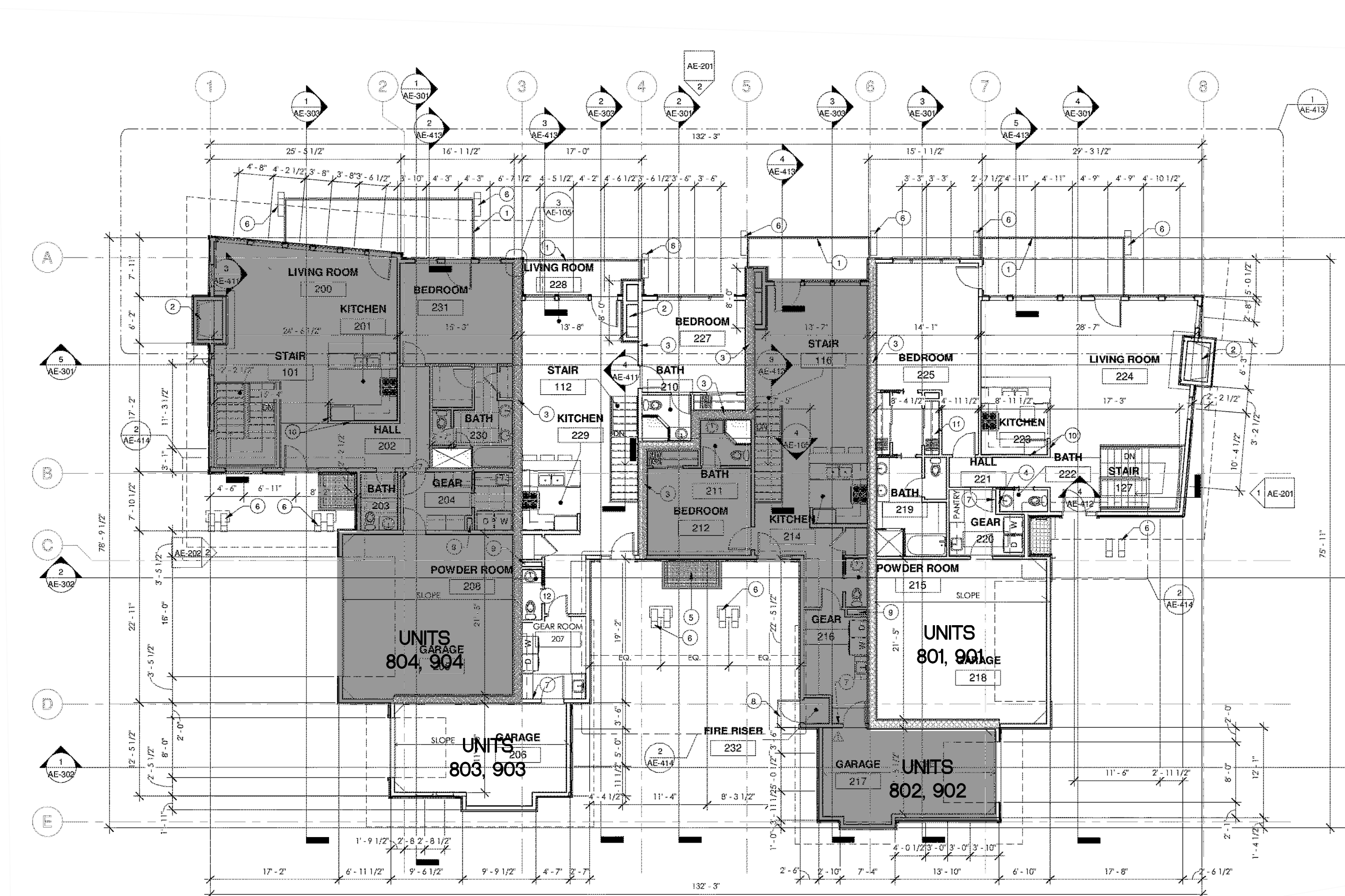

 FLOOR PLAN**

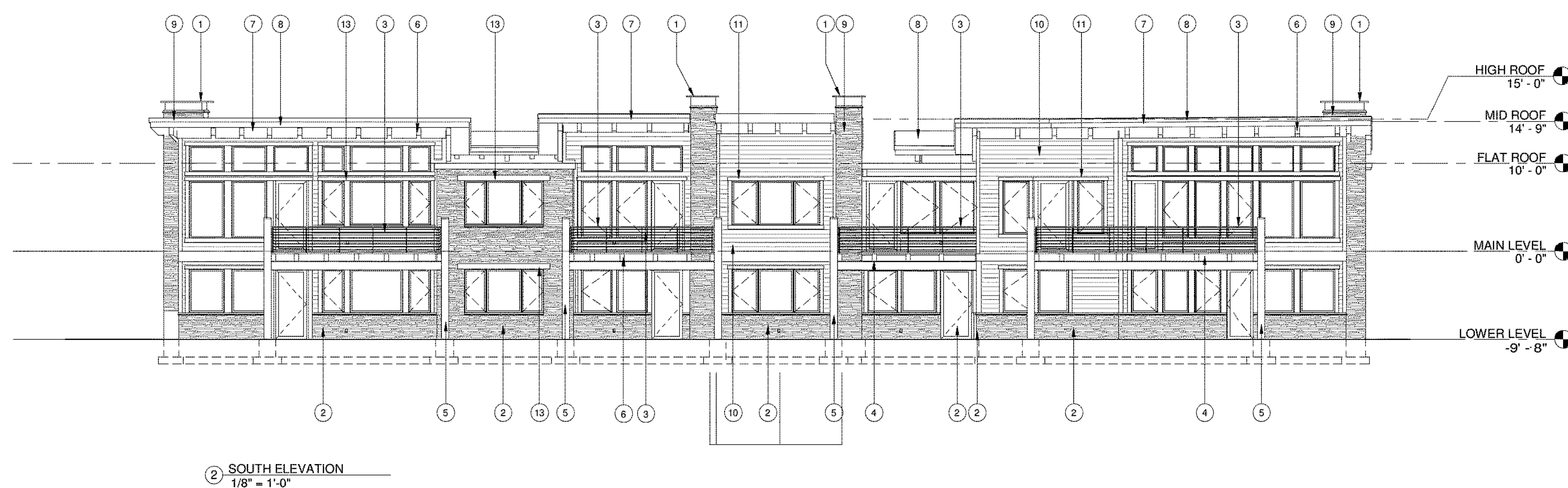
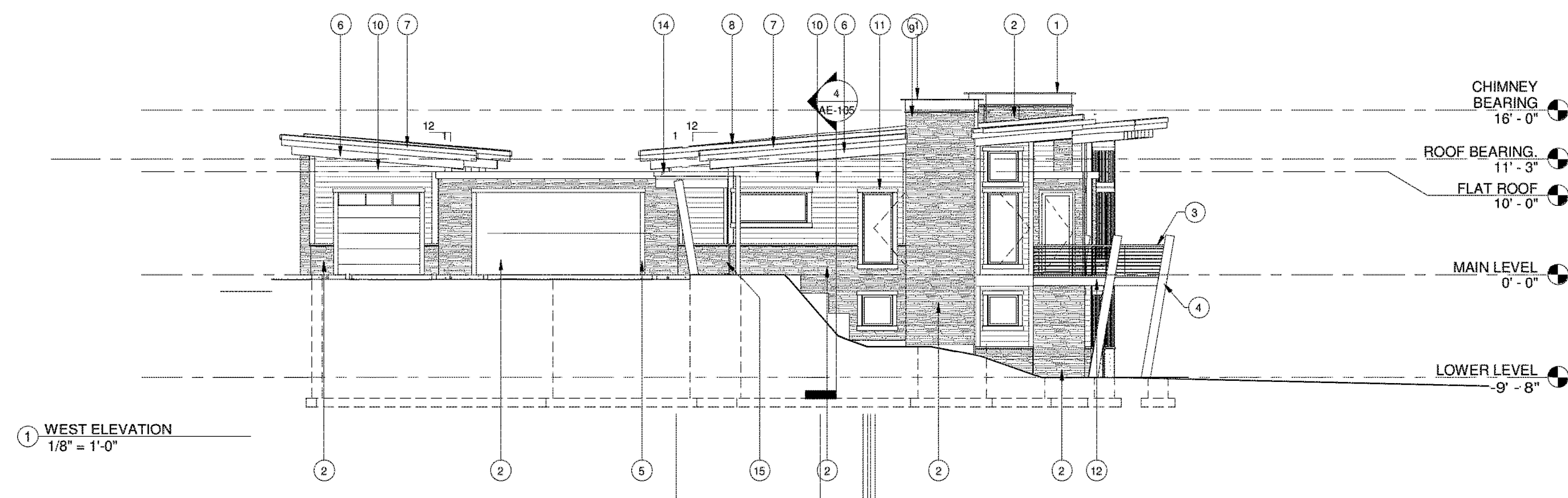
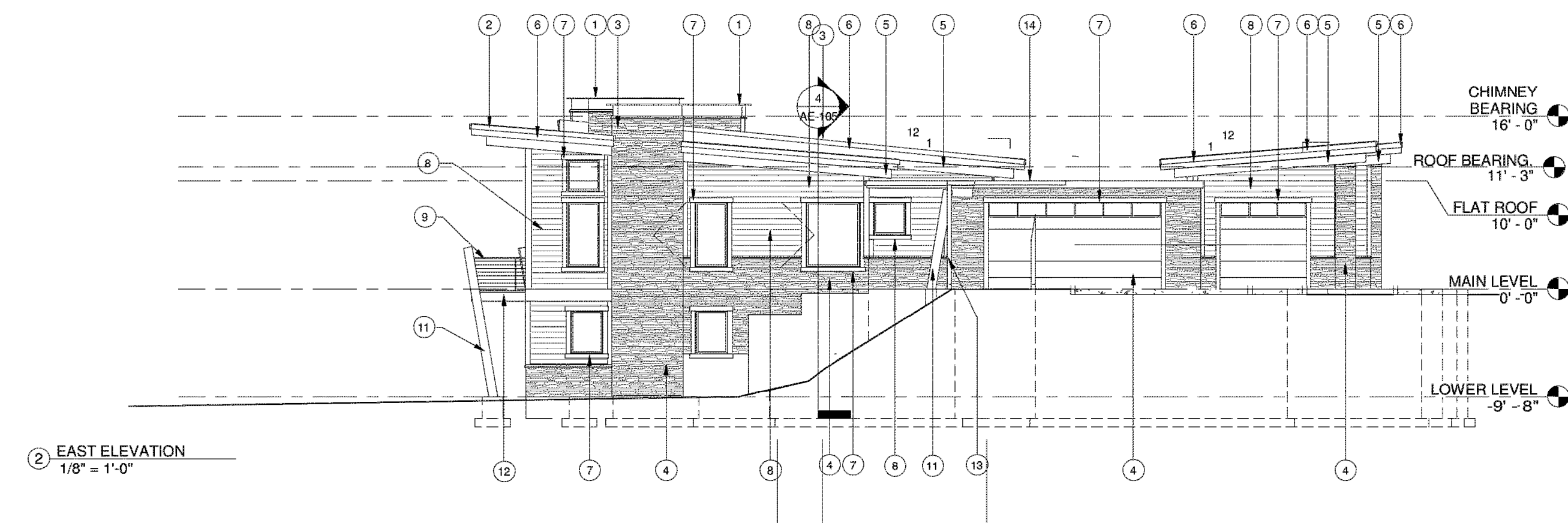
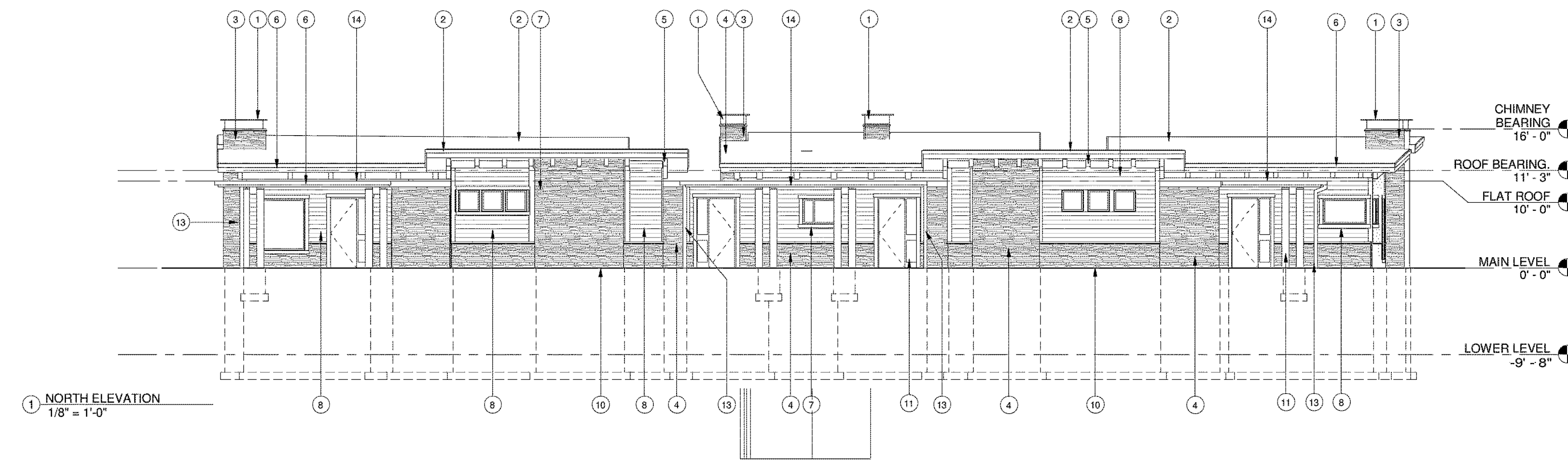


**MAIN LEVEL
