Comments

The helicopter will be used for heli-biking and heli-fishing from June 1 to September 30 each year. During the winter season, from December 1 to April 15, the helicopter will be used for heli-skiing. The hours of operation are from 7AM to 6PM. The operation is limited to 3 days per week with a maximum of 10 operations (trips) in a single day. A maximum of 24 guests to be served per day. The dust control measures must be done with an environmentally friendly product. The flight paths must follow the flight paths as listed on the application. The applicant must comply with any federal, state, or local regulations regarding helicopter gas emissions and noise. If the applicant wishes to shuttle people from the valley floor a conditional use permit amendment will be required and it must be demonstrated that the shuttle pickup location is an approved use in the zone in which it is located. The applicant will be required to comply with all federal and state regulations.
