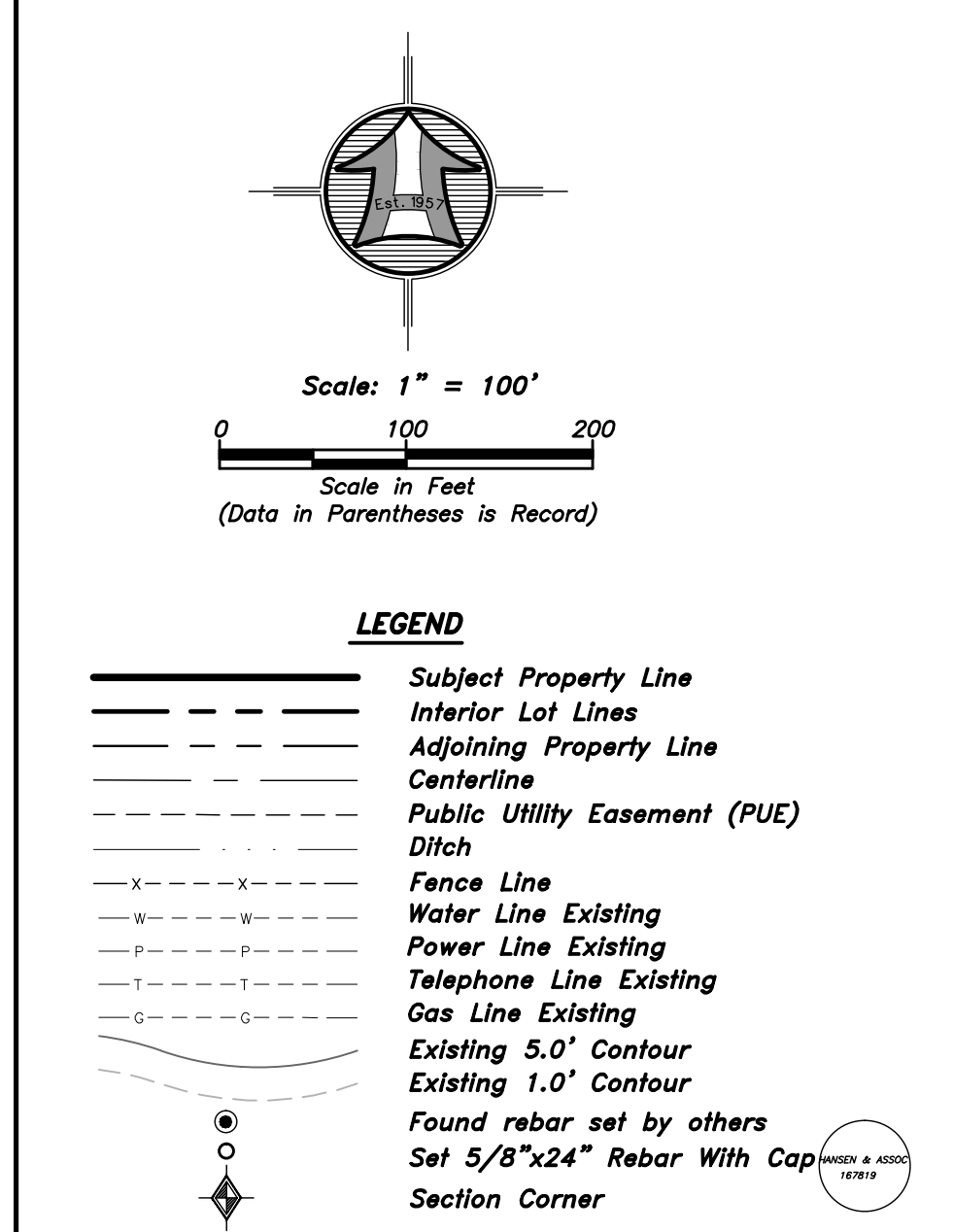
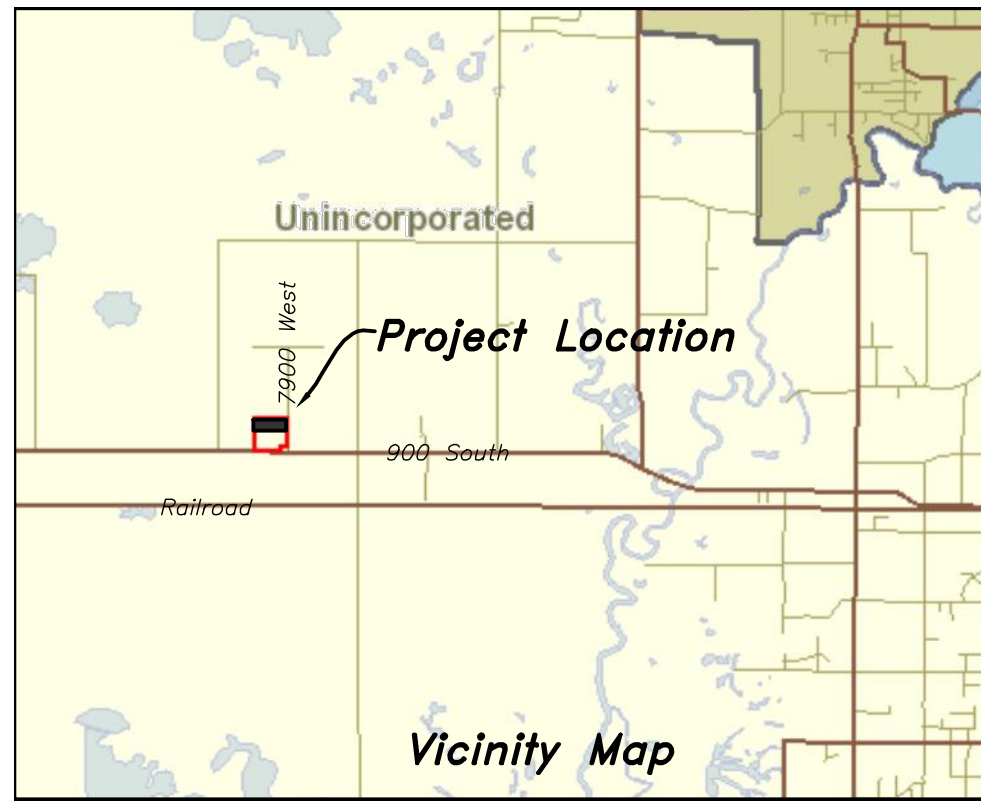

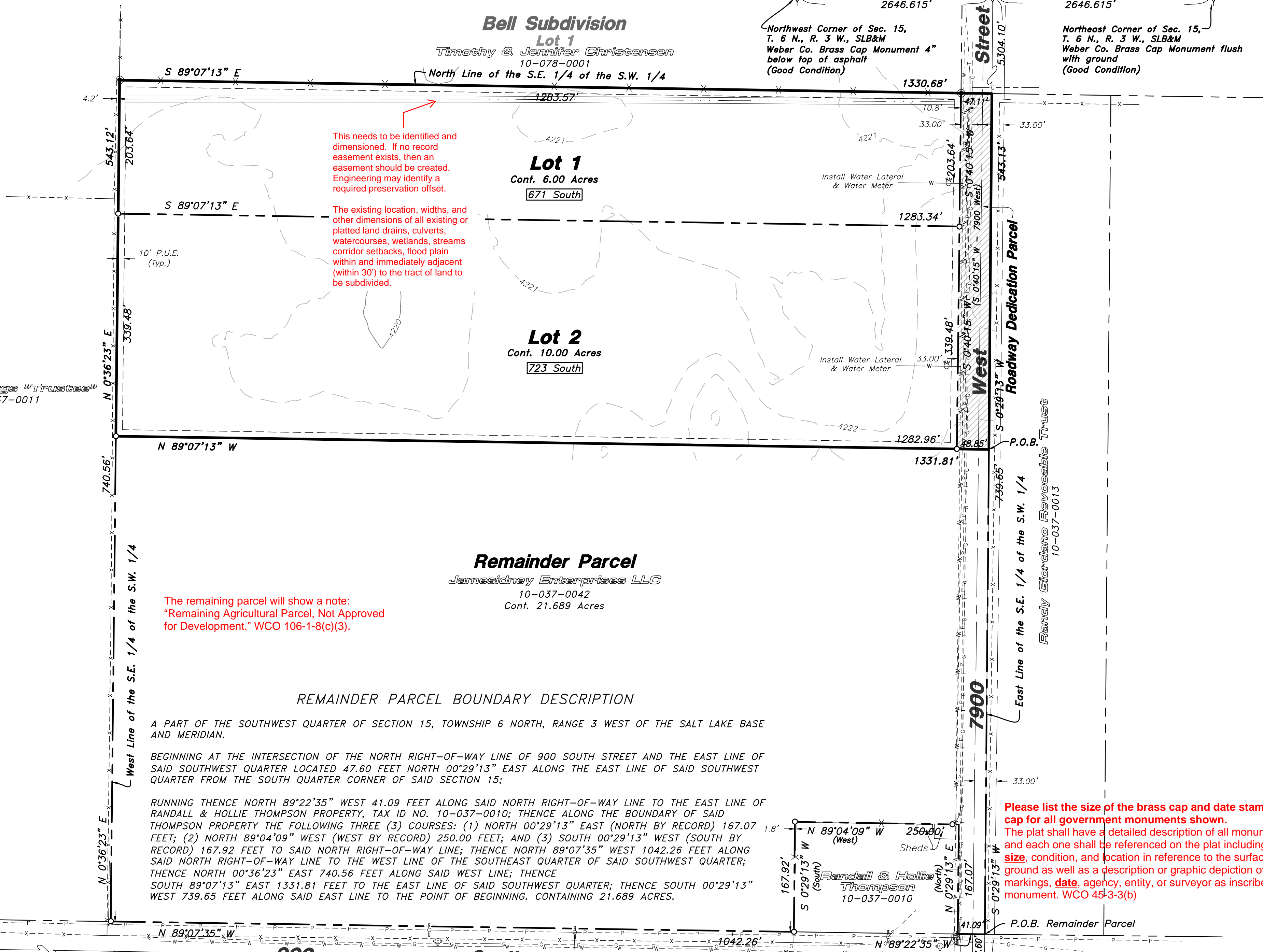

A PART OF THE SOUTHWEST QUARTER OF SECTION 15, TOWNSHIP 6 NORTH, RANGE 3 WEST OF THE SALT LAKE BASE AND MERIDIAN.

BEGINNING AT A POINT ON THE EAST LINE OF SAID SOUTHWEST QUARTER LOCATED 787.25 FEET NORTH 00°29'13" EAST ALONG THE EAST LINE OF SAID SOUTHWEST QUARTER FROM THE SOUTH QUARTER CORNER OF SAID SECTION 15;

The purpose of this survey was to establish and set the property corners of the Two Lot Subdivision as shown and described hereon. This survey was ordered by Tom Close. The control used to establish the property corners was the existing Weber County Surveyor Monumentation surrounding Section 15, Township 6 North, Range 3 West, S.L.B.&M. The North Right-of-Way of 900 South Street was determined from Entry No. 2736753 in the Weber County Recorder's Office. The Right-of-Way and Bearing of 7900 West Street was determined from Fall Widow Subdivision Phase 2 recorded as Entry No. 2891540. The basis of bearing is the South line of the Southwest Quarter of said Section which bears North 89°04'06" West, Utah North, State Plane, Calculated N.A.D.83 Bearing.
