

BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN THE EAST QUARTER CORNER AND THE NORTHEAST CORNER OF SECTION 34, T.7N., R.1E., S.L.B.&M., U.S. SURVEY. SHOWN HEREON AS N00°17'22"W.

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO DIVIDE THE BELOW DESCRIBED PROPERTY INTO LOTS AS SHOWN. ALL BOUNDARY AND LOT CORNERS WERE SET WITH A 5/8" X 24" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".

BOUNDARY DESCRIPTION

A PART OF THE EAST HALF OF SECTION 34, AND THE SOUTHWEST QUARTER OF SECTION 35, TOWNSHIP; 7 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, DESCRIBED AS FOLLOWS:

ALL OF LOT 2, VALLEY CENTER ESTATES, ON FILE IN THE WEBER COUNTY RECORDER'S OFFICE IN BOOK 38, AT PAGE 17 OF OFFICIAL RECORDS.

ALSO DESCRIBED AS BEING 47.93 FEET NORTH 00°17'22" WEST ALONG SECTION LINE AND 72.33 FEET NORTH 89°21'51" WEST ALONG THE SOUTH LINE OF 2300 NORTH STREET, FROM THE EAST QUARTER CORNER OF SECTION 34, TOWNSHIP 7 NORTH, RANGE 1 EAST, SALT LAKE BASE AND MERIDIAN, AND RUNNING THENCE SOUTH 01°40'11" WEST 314.85 FEET; THENCE SOUTH 88°47'22" EAST 165.71 FEET, TO THE WEST LINE OF 5500 EAST STREET; THENCE ALONG SAID WEST LINE, SOUTH 02°40'32" WEST 278.95 FEET, TO THE NORTH LINE OF 2200 NORTH STREET; THENCE ALONG SAID NORTH LINE, NORTH 88°41'34" WEST 264.77 FEET, TO THE SOUTHEAST CORNER OF LOT 1, VALLEY CENTER ESTATES; THENCE ALONG THE EAST LINE OF SAID LOT 1, VALLEY CENTER ESTATES, NORTH 00°58'38" EAST 592.14 FEET, TO THE SOUTH LINE OF 2300 NORTH STREET; THENCE ALONG SAID SOUTH LINE, SOUTH 89°21'51" EAST 111.13 FEET TO THE POINT OF BEGINNING.
