- 2. EXISTING UNDERGROUND UTILITIES AND IMPROVEMENTS ARE SHOWN IN THEIR APPROXIMATE LOCATIONS BASED UPON RECORD INFORMATION AVAILABLE AT THE TIME OF PREPARATION OF PLANS. LOCATIONS MAY NOT HAVE BEEN VERIFIED IN THE FIELD AND NO GUARANTEE IS MADE AS TO ACCURACY OR COMPLETENESS OF THE INFORMATION SHOWN. IT SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR TO DETERMINE THE EXISTENCE AND LOCATION OF THOSE UTILITIES SHOWN ON THESE PLANS OR INDICATED IN THE FIELD BY LOCATING SERVICES.  STAINLESS STEEL SADDLES WITH CORP-STOP AT SADDLE. ROMAC MUELLER, OR
 APPROVED EQUAL SADDLES AND CORP-STOP VALVES (INSTALL PER MANUFACTURES RECOMMENDATIONS).
- 2) 4"ø SANITARY SEWER LATERAL PER PMWSID PLAN NO. 431S.
- 3) SAW CUT TO PROVIDE SMOOTH CLEAN EDGE.
- REMOVE AND PROPERLY DISPOSE OF ASPHALT AS NEEDED. REPLACE ASPHALT TO MATCH EXISTING CONDITIONS.
- (5) EXISTING 10"Ø WATER MAIN STUB.
