



THE PURPOSE OF THIS PLAT IS TO DIVIDE THE BELOW DESCRIBED PROPERTY INTO A LOT. ALL LOT CORNERS WERE SET WITH A 5/8" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES". RIVER DRIVE RIGHT OF WAY WAS LOCATED BY RETRACEMENT OF SURVEY OF RIVER DRIVE BY WEBER COUNTY SURVEYOR. (1975)
