## MEMORANDUM OF UNDERSTANDING FOR REIMBURSABLE SERVICE

This Memorandum of Understanding is made and entered into by and between Weber County Sheriff's Office and STEPT LLC.

## SECTION ONE AGREEMENT

- 1.01 The County, through the Weber County Sheriff's Office, agrees to furnish law enforcement services and to enforce state laws and city ordinances within the corporate limits of Weber County to the extent and in the manner hereinafter set forth.
- 1.02 The Weber County Sheriff's office agrees to assign deputies to provide law enforcement activities at and near the SR39 (Ogden Canyon), SR167 (Trappers Loop), SR226 (Snowbasin Rd) on behalf of the STEPT LLC.
- 1.03 Flexibility is recognized in the schedule to allow for a response from that deputy or deputies for any unforeseen or emergency situations that may arise during the assignment.
- Approximate hours scheduled for security, crime prevention and law enforcement services are estimated at <u>12</u> hours for these events. Deputy services are reimbursed at \$50.00 per hour. The scheduled event(s) is/are from 0800 on Thursday April 29, 2021 to 2000 Thursday 29, 2021. The Deputy will be positioned in these areas to provide a law enforcement presence.
- 1.05 The officers assigned to duty in items 1.02 will be full-time, trained sworn officers of the Weber County Sheriff's Office and will be supervised and directly responsible to the Weber County Sheriff or designee.
- 1.06 Nothing in this agreement shall be construed as obligating **STEPT LLC** to expand in any obligation for the future payment of money in excess of appropriation authorized by law and administratively made available for this work.

## SECTION TWO RATE SCHEDULE FOR REIMBURSABLE SERVICES

- 2.01 <u>STEPT LLC</u> agrees to reimburse the Weber County Sheriff's Office on receipt of satisfactory statements of expenditures in accordance with the following schedule, for the period established in this plan, unless circumstances arise that required additional time.
- 2.02 <u>STEPT LLC</u> agrees to reimburse the Sheriff's Office at the rate of \$50.00 per hour, per officer, during the planned period.

  Billing for reimbursement will be furnished within 30 days at the end of the said services. Billings should be made out to Weber County Sheriff's Office. Itemized statements for expenditures will be furnished with each billing.
