

BOUNDARY DESCRIPTION



Basis of Bearing for subject parcel being North 89°12'03" West 5296.08 feet (measured) between the Weber County brass cap monuments monumentalizing the East and West Quarter Corners of said section 21. Subject parcel being more particularly described as follws:
