Notice of Termination (NOT) for Storm Water Discharges Associated with Construction Activity Under the UPDES General Permit No. UTRC00000.

Submission of this Notice of Termination constitutes notice that the owner/operator identified in Section II of this form or in the NOI is/are no longer authorized to discharge storm water associated with industrial activity under the UPDES program. The owner for current permit coverage must terminate coverage where another party assumes ownership and responsibility even if the site remains unstabilized. A person cannot take responsibility for a permit unless they are the owner or lease holder for the property where the construction activity will occur. Areas of the site that become finally stabilized should be terminated at one time when all portions of the site are stabilized and permit coverage for the project is terminated (unless portions of the site are sold). ALL NECESSARY INFORMATION MUST BE PROVIDED ON THIS FORM.



Instructions for Completing Notice of Termination (NOT) Form

Who May File A Notice Of Termination (NOT) Form

Permittees who are presently covered under the State issued Utah Pollutant Discharge Elimination System (UPDES) General Storm Water Permit for Construction Activity may submit a notice of termination (NOT) form when their facilities no longer have any storm water discharges associated with industrial activity (construction activity) as defined in the storm water regulations at UAC R317-8-3.9(6)(d)10 or (e)1, or when they are no longer the legal owner or person responsible for the project and the facilities.

For construction activities, the permittee must eliminate all storm water discharges associated with industrial (construction) activity, stabilize all disturbed soils at the construction site except for arid and semi-arid areas where alternative efforts to control the surface until stabilization can be accomplished, and remove temporary erosion and sediment control measures except where it is acceptable in arid and semi-arid areas where biodegradable or permanent BMPs may remain. Final stabilization means that all soil-disturbing activities at the site have been completed, and that a uniform perennial vegetative cover with a density of 70% has been established on all unpaved areas and areas not already covered by permanent structures, or equivalent permanent stabilization measures (such as the use of riprap, gabions, or geotextiles) have been employed. Or for arid and semi-arid areas, the surface has been designed and prepared that with time vegetation will provides or is expected to provide a uniform (e.g., evenly distributed, without large bare areas) perennial vegetative cover with a density of 70 percent of the natural background vegetative cover, or (2) non-vegetative stabilization methods have been implemented to provide effective cover for exposed portions of the site.

Section I – Permit/Site Information

Enter the existing UPDES Storm Water General Permit number assigned to the facility or site identified in Section III. If you do not know the permit number, contact the Division of Water Quality at (801) 536-4300. Answer all questions and provide information concerning other responsible parties if applicable. Where another party assumes responsibility over a portion of the site, you must show in the SWPPP for the site appropriate documentation of the date and the area of the site involved in the transfer of responsibility.

Section II - Facility Operator Information

This form must be filled out and submitted by the owner or lessee listed on the notice of **intent** (NOI) that was submitted for receiving coverage under this permit. In this section give the legal name of the person, firm, public organization, or any other entity that is filed as the owner at the facility or site described in this application that desires to terminate coverage. The owner or lessee of the facility is the legal entity which has ultimate controls the facility's operation (referring to operation of construction activity) or a portion of it, rather than the plant or site manager of the finished or rehabilitated facility. Do not use a colloquial name. Enter the complete address and telephone number of the operator. If there are more than one operators additional NOT forms must be filled out and submitted with those operators including the required information and signatures.

Section III - Facility/Site Location Information

Enter the facility's or site's official or legal name and complete address, including city, state and ZIP code and the latitude and longitude of the facility to the nearest 15 seconds of the approximate center of the site.

Section IV - Certification

State statutes provide for severe penalties for submitting false information on this application form. State regulations require this application to be signed as follows:

For a corporation: by a responsible corporate officer, which means: (i) president, secretary, treasurer, or vice-president of the corporation in charge of a principal business function, or any other person who performs similar policy or decision making functions, or (ii) the manager of one or more **manufacturing**, production, or operating facilities employing more than 250 persons or having gross annual sales or expenditures exceeding \$25 million (in second-quarter 1980 dollars), if authority to sign documents has been assigned or delegated to the manager in accordance with corporate procedures; or by a duly authorized representative (See permit part 5.16.1.b. for a definition of duly authorized representative).

For a partnership or sole proprietorship: by a general partner or the proprietor, respectively; or

For a municipality, State, Federal, or other public facility: by either a principal executive officer or ranking elected official.
