

NARRATIVE

This survey was performed to create a 1 lot subdivision as shown. It is a 3 acre minimum zone and a variance with Weber County has been granted provided a the remaining 1.73 acres remain undeveloped on the remaining parent parcel to this property. The South boundary is held to the 2650 North right of way as dedicated in 1986. The West boundary is held to the East line of lot 2, Kimbers subdivision as recorded. The East boundary is matched to the bearing and distance call on the current deeds. The chain link fence is not on the boundary line and was most likely placed conveniently away from an existing ditch. Basis of bearing is State plane grid bearings as shown on Weber County records.
