**ORDINANCE 2022-\_\_\_\_\_**

**AN ORDINANCE TO AMEND VARIOUS SECTIONS OF THE WEBER COUNTY LAND USE CODE TO DEFINE AND REGULATE ANIMAL GRAZING, ANIMAL FEEDING OPERATIONS, AND LARGE CONCENTRATED ANIMAL FEEDING OPERATIONS.**

**WHEREAS,** The Board of Commissioners of Weber County has heretofore adopted a land use code that includes zones for the purpose of providing for an orderly development of land; and

**WHEREAS,** The Utah State Legislature adopted S.B. 130 during the 2021 General Session which enacted the Large Concentrated Animal Feeding Operations Act requiring that County adopt an ordinance regulating Large Concentrated Animal Feeding Operations by no later than February 1<sup>st</sup> 2022; and

**WHEREAS,** On, January 4<sup>th</sup> 2022, the Western Weber Planning Commission offered a favorable recommendation for the regulation proposed herein; and

**WHEREAS,** On, January 25<sup>th</sup> 2022, the Ogden Valley Planning Commission offered a favorable recommendation for the regulation proposed herein; and

**WHEREAS,** The proposed ordinance is consistent with the goals and objectives of both the 2003 West Central Weber General Plan and the 2016 Ogden Valley General Plan; and

**NOW THEREFORE,** be it ordained by the Board of Commissioners of Weber County, in the State of Utah, as follows:

**SECTION 1: AMENDMENT.** The Weber County Code is hereby *amended* as provided in **Exhibit A**. Any part of the Weber County Code not explicitly provided herein shall remain unchanged. For all text herein, text in blue underline is being added, text in red strikeout is being deleted.

1 **Sec 101-2-2 An-Definitions**

2 Animal feeding operation. The term "animal feeding operation" means a lot or facility where the following  
3 conditions are met:

- 4 (a) animals have been, are, or will be stabled or confined and fed or maintained for a total of 45 days  
5 or more in any 12-month period; and
- 6 (b) the area of confinement devoted to the feeding of the animals does not sustain grazing vegetation  
7 during the normal growing season for the purpose of feeding the confined animals.

8 Animal feeding operation, large concentrated. The term "large concentrated animal feeding operation"  
9 means the same as provided in the Large Concentrated Animal Feeding Operations Act of State Code.

10 Animal grazing. The term "animal grazing" means the pasturing or ranging of animals for the purpose of  
11 grazing at an animal density that does not exceed the land's ability to perpetually sustain vegetation for  
12 grazing during the normal growing season.

13 Animal/veterinary hospital. The term "animal/veterinary hospital" means any building or structure used  
14 for medical and/or surgical care, treatment of animals, including boarding of domesticated animals. The  
15 term "animal/veterinary hospital" does not include an animal rescue facility, nor an animal sanctuary.

16 Antenna. The term "antenna" means any system of wires, poles, rods, reflecting discs, or similar devices  
17 used for the transmission or reception of electromagnetic waves external to or attached to the exterior of  
18 any building and including the supporting structure; includes, but is not limited to amateur radio antennas,  
19 television antennas, an

21 **Sec 104-1-2 Boundaries Of Zones**

- 22 (a) The boundaries of each of the said zones are hereby established as described herein or as shown  
23 on the maps entitled "Zoning Map of Weber County", which map or maps are attached and all  
24 boundaries, notations and other data shown thereon are made by this reference as much a part of  
25 this title as if fully described and detailed herein.

26 (b) Where uncertainty exists as to the boundary of any zone, the following rules shall apply:

27 (1) Wherever the zone boundary is indicated as being approximately upon the centerline of  
28 a street, alley or block, or along a property line, then, unless otherwise definitely  
29 indicated on the map, the centerline of such street, alley or block or such property line,  
30 shall be construed to be the boundary of such zone.

31 (2) Whenever such boundary line of such zone is indicated as being approximately at the  
32 line of any river, irrigation canal or other waterway or railroad right-of-way, or public  
33 park or other public land or any section line, then in such case the center of such stream,  
34 canal or waterway, or of such railroad right-of-way or the boundary line of such public  
35 land or such section line shall be deemed to be the boundary of such zone.

36 (3) Where such zone boundary lines cannot be determined by the above rules, their location  
37 may be found by the use of the scale appearing upon the map.

38 (4) Where the application of the above rules does not clarify the zone boundary location, the  
39 board of adjustment shall interpret the map.

60 The Land Use Table or list of permitted uses and conditional uses of each zone are plenary. As such, the  
61 following rules of interpretation apply:

62 (a) A use that is not explicitly listed as a permitted or conditional use in the respective zone is not an  
63 allowed use in that zone.

64 (b) The omission of a use from a zone's Land Use Table or a zone's list of permitted or conditional  
65 uses shall not be construed in any manner as an allowed use in the zone.

66 (c) A use that is specifically listed in one zone's Land Use Table or the zone's list of permitted or  
67 conditional uses that is not specifically listed in another zone's Land Use Table or list of permitted  
68 or conditional uses is not permitted in the other zone.

79 **Sec 104-2-4 Special Regulations**

80 The uses listed below correspond with certain uses listed in the Land Use Table in Section 104-2-3. Due to  
81 the nature of the use, each shall be further regulated as follows:

82 (a) Animal grazing. This use shall not include the supplementary or full feeding of the animals,  
83 except when in compliance with the following:

84 (1) It may only be carried on during times that are reasonable and necessary due to lack of  
85 natural growing feed as a result of seasonal changes or extreme and temporary  
86 meteorological events.

87 (2) It shall not exceed a density of 25 head per acre of used land in the AV-3 and A-1 zones,  
88 and 40 head per acre of used land in the A-2 and A-3 zones;

89 (3) It shall not be closer than 75 feet to any dwelling, public or semi-public building on an  
90 adjoining parcel of land; and

91 (b) Animal feeding operation. This use may include supplemental or full feeding. However, it is  
92 prohibited to feed animals any market refuse, house refuse, garbage, or offal that was not  
93 produced on the premises. The following additional standards apply for hog feeding:

94 (1) All pens and housing for hogs shall be concrete and maintained in a sanitary manner.

95 (2) Drainage structures and disposal of animal waste shall be provided and properly  
96 maintained as required by the local health department.

97 (c) Animal feeding operation, large concentrated. A large concentrated animal feeding operation  
98 shall not be located within a half-mile of a zone boundary, unless the boundary is shared with  
99 another zone in which this use is allowed. Additionally, the area of confinement devoted to the

100 [feeding of the animals in any new large concentrated animal feeding operation shall be set back](#)  
101 [at least one quarter-mile from every property boundary.](#)

102 ~~(a)~~(d) **Corral, stable or building for keeping animals or fowl.** This use shall be located no less  
103 than 100 feet from a public street and not less than 25 feet from any side or rear lot line.

104 ~~(b)~~(e) **Custom exempt meat cutting.** This use shall be limited to animals that are part of one or  
105 more livestock operation(s) in Weber County. This use shall only occur if it is accessory to a  
106 dwelling onsite, completely enclosed within a building with no outdoor storage, and located on  
107 and with access directly from a collector or arterial street.

108 ~~(e)~~(f) **Dog breeding, dog kennels, or dog training school.** This use shall not exceed ten dogs of  
109 more than ten weeks old, per acre, at any time. Any building or enclosure for animals shall be  
110 located not less than 100 feet from a public street and not less than 50 feet from any side or rear  
111 property line.

112 ~~(d)~~(g) **Family food production.**

113 (1) As used in this subsection, a Group A animal is either one pig, one sheep, one cow, or  
114 one goat, and Group B animals or fowl are either a set of ten rabbits, ten chickens, ten  
115 pheasants, five turkeys, five ducks, five geese, or five pigeons.

116 (2) No more than four sets of Group B animals or fowl may be kept on a lot or parcel that  
117 is less than 40,000 square feet.

118 (3) No more than six combined Group A animals and sets of Group B animals or fowl may  
119 be kept on a lot or parcel that is less than two acres. The same applies to a lot or parcel  
120 greater than two acres, except that an additional six combined Group A and and sets of  
121 Group B animals or fowl may be kept per each additional acre greater than two.

122 ~~1. Hog farm.~~

123 ~~1. Hog farm, small.~~ This use is limited to not more than ten hogs, more than 16 weeks old. It  
124 is prohibited to feed hogs any market refuse, house refuse, garbage, or offal that was not  
125 produced on the premises.

126 ~~2. Hog farm, large.~~ It is prohibited to feed hogs any market refuse, house refuse, garbage, or  
127 offal that was not produced on the premises. All pens and housing for hogs shall be concrete  
128 and maintained in a sanitary manner. Drainage structures and disposal of animal waste  
129 shall be provided and properly maintained as required by the local health department.

130 ~~2. Raising and grazing of horses, cattle, sheep or goats.~~ This use shall not include the supplementary  
131 or full feeding of the animals in conjunction with any livestock feed yard, livestock sales, or  
132 slaughterhouse except when in compliance with the following:

133 ~~1. It shall not exceed a density of 25 head per acre of used land in the AV-3 and A-1 zones,~~

140 ~~(e)~~(h) **Parking of construction vehicle.** The off-site for-profit nonagricultural use of the  
141 construction vehicle shall be restricted to the owner or operator of an actively operating

142 agricultural use on the same lot or parcel on which it is parked, or the owner or operator's  
 143 employee. This use shall:

- 144 (1) Be accessory to an actively-operating agricultural use on the lot or parcel;
- 145 (2) Be restricted to vehicles and related equipment that are used for the actively-operating  
 146 agricultural use;
- 147 (3) Include no more than one three-axle truck, and no pups.

148 ~~(g)~~(i) **Parking of large vehicle.** This use shall be restricted to one vehicle, no greater than 24,000  
 149 pound GVW, which shall be parked at least 50 feet from a public street. Recreational vehicles are  
 150 exempt from these restrictions.

151 ~~(g)~~(j) **Temporary building or use.** The building or use shall be removed upon completion or  
 152 abandonment of the construction work.

162 The uses listed below correspond with certain uses listed in the Land Use Table in Section 104-21-3. Due  
 163 to the nature of the use, each shall be further regulated as follows:

164 (a) **Animal grazing.** This use shall not include the supplementary or full feeding of the animals,  
 165 except when in compliance with the following:

166 (1) It may only be carried on during times that are reasonable and necessary due to lack of  
 167 natural growing feed as a result of seasonal changes or extreme and temporary  
 168 meteorological events.

169 (2) It shall not exceed a density of 25 head per acre of used land in the AV-3 and A-1 zones,  
 170 and 40 head per acre of used land in the A-2 and A-3 zones;

171 (3) It shall not be closer than 75 feet to any dwelling, public or semi-public building on an  
 172 adjoining parcel of land; and

173 (b) **Animal feeding operation.** This use may include supplemental or full feeding. However, it is

183 accommodate a setback of not less than a quarter-mile to any property boundary.

184 ~~(d)~~ (d) **Automobile recycling (parts dismantling).** This use shall be conducted within a completely  
185 enclosed building. In the M-2 zone, the recycling facility shall have no more than 40 automobiles  
186 at the site at any one time. Any automobile recycling vehicle storage area must be enclosed by a  
187 solid wall or fence of not less than seven feet in height

188 ~~(e)~~ (e) **Building material sales yard.** In the M-1 zone, a building material sales yard may include  
189 the sale of rock, sand, gravel and the like, as an incidental part of the main business, but shall  
190 exclude concrete mixing except as such concrete mixing is necessary in the preparation and  
191 manufacture of any of the products specified in this section.

192 ~~(f)~~ (f) **Cement batch plants.** The following standards apply to a cement batch plant:

193 (1) The cement silo mixer shall not be larger than 300 barrel in the M-1, M-2, and M-3  
194 zones, and 200 barrel in the MV-1 zone.

195 (2) There shall be a 15-foot landscape buffer with a six-foot-high earth berm planted with  
196 six feet or larger evergreen trees. The trees shall be Canada Hemlock, Scotch Pines,  
197 Douglas Fir, or Blue Spruce. The trees shall be planted every 15 feet on center. The  
198 evergreen shrubs shall be Junipers, Mugo Pines, or Spreading Yew. The shrubs shall be  
199 36 inches high and there shall be 15 shrubs per 100 feet. There shall be five canopy trees  
200 per 100 feet. These trees shall be Maples, Linden, Quaking Aspens, Cottonless  
201 Cottonwood, Honey Locust, or Birch trees. These trees shall be a minimum of two-inch  
202 caliper. This landscaping shall be planted on the crest of the six-foot berm when the  
203 property abuts agricultural or residential zones.

204 (3) There shall be no more than three cement trucks, and no more than two other semi-trucks  
205 and trailers used with this operation stored on site.

206 (4) There shall be no more than 40 yards of sand and gravel mix stored on this site. The sand  
207 and gravel mix shall be stored in a three-wall bin and covered when not in use.

208 (5) All cement product on site shall be stored within the silo. At least 15,000 square feet of  
209 the lot shall be dedicated for this use.

210 (6) The property shall be at least one acre in size.

211 (7) A vehicle/trailer washout area is required. A detailed plan for the washout area shall be  
212 submitted with the permit application.

213 ~~(g)~~ (g) **Dwelling unit for night watchman or guard and family.** The dwelling unit shall be for the  
214 exclusive use of a night watchman or guard and his or her immediate family. The site shall provide  
215 an additional 3,000 square feet of landscaped area for the residential use.

216 ~~(h)~~ (h) **Retail sales, limited.** This use is limited to the sales of products produced by, developed in  
217 conjunction with, or normally required and used in the performance of a commercial or  
218 manufacturing operation permitted in this zone, and provided the retail sales is clearly an  
219 accessory use to the main permitted use and is conducted within the same building or, if the main  
220 use is not a building, then on the same property. No retail sale of products may be made in  
221 conjunction with a warehousing or wholesale business.

222 ~~(i)~~ (i) **Shooting range or training course, indoor or outdoor.** The facility shall provide  
223 designated shooting positions for which ballistic backstops are designed. No shooting is allowed  
224 except in these designated shooting positions. All sides down range of a shooting position shall  
225 have a non-ricochet ballistic backstop, including overhead and on the ground or floor, capable of  
226 containing all errant bullets. For an outdoor range, the overhead backstop may be a series of

227 baffles. Approval shall be subject to the requirements and conditions of the local fire authority.  
228 The range operator shall be onsite at all times shooting is occurring.
