Response to Surveyor's Comments

Mr. Slagkowski,

The following are comments and responses pertaining to the Summit Eden Phase 1A Plat from your review and received on December 11, 2013.

## Sheet 1:

1. Each curve and line must have a unique number, line and curve numbers are used in tables on both sheets 2 and 4.

Response: Updated, re-numbered and re-checked all line and curve tag's for Phase 1A

2. There are a lot of issues with annotations, as redlined. Please check all annotations before resubmitting including annotation not redlined to ensures correctness

Response: Updated, re-numbered and re-checked all line and curve tags for Phase 1A.

3. The drawing you submitted to us do not scale correctly, please address.

Response: In the publishing options in AutoCAD it was scaling a few of the PDF to fit to paper causing a very slight scaling issue which has been corrected.

4. Please show location of monument to be set in Horizon Run.

Response: Added street monument's per NV5 engineer's locations.

5. This is located in the S.W. ¼ of 5, S. ½ of 6, N. ½ of 7 and N.W. ¼ of 8

Response: Update title block on all sheets with above information.

## **Sheet 2:**

1. Distance (of Parcel B#) does not reach boundary

Response: We check this distance multiple times and we show the distance of 2882.70 feet reaching the boundary line.

2. Rounding error Curve # 27 and # 28

Response: Updated C27 by .01, both C27 and C28 actual distance to the thousand of a foot was .006 creating a rounding up error.

## **Sheet 3:**

1. Upper left corner page, Check these annotations, why three calls on the curve? What is the leader with no text?

Response: updated curve information to 2 calls and removed unused leader.

2. C75 not in curve table.

Response: Added C75 to curve table and renumbered to C93

3. Missing call on Building Envelope of Lot 8.

Response: Added call to southeast corner of Building Envelope on Lot 8

4. Correct B.E acres on lots 7A, 7B, 22R

Response: Corrected B.E. on above lots.

5. Why two call? Missing line (C12-L6)

Response: Created one curve call from two, L5 now L44 was masked behind another label, now visible.

6. Ski easement Ties and dimensions for ski lift parcel along road

Response: Added ties and dimensions to ski lift easement and adjacent parcels

7. Southern boundary line, Rounding errors and sum of three calls not adding up.



Response: corrected call 21.17 to 21.16(actual distance 21.166). Missing line length 35.15 from outer southern lot line label, now both sheet 2 and 3 match.

8. Location of 10' sanitary sewer easement and dimensions.
