A TWENTY (20) FOOT EASEMENT FOR THE CONSTRUCTION, MAINTENANCE AND OPERATION OF A SANITARY SEWER LINE LOCATED IN THE SW QUARTER OF SECTION 28, TOWNSHIP 6 NORTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, SAID EASEMENT TO BE 10 FEET EACH SIDE OF THE FOLLOWING DESCRIBED CENTER LINE:

BEGINNING AT A POINT ON THE SOUTH LINE OF GRANTOR'S PROPERTY, SAID POINT LIES \$89°13'14"E, 1324.19 FEET AND \$00°35'47"W, 1326.24 FEET AND \$89°11'40"E, 618.44 FEET FROM THE WEST QUARTER CORNER OF SAID SECTION 28, THENCE N00°42'51"E, 252.02 FEET; THENCE N89°11'45"W, 393.05 FEET; THENCE N00°46'46"E, 177.71 FEET TO THE POINT OF TERMINUS.

To have and hold the same unto the Grantee, its successors and assigns, with the right of ingress and egress in the Grantee, its officers, employees, agents and assigns to enter upon the above described property with such equipment as is necessary to construct, install, maintain, operate, repair inspect, protect, remove and replace the Facilities during construction periods, Grantee and its contractors may use such portion of Grantors property along and adjacent to the right-of-way and easement as my be reasonably necessary in connection with the construction or repair of the Facilities The contractor performing the work shall restore all property, through which the work traverses, to use near its original condition as is reasonable possible Grantors shall have the right to use the above described property except for the purposes for which this right-of-way and easement is granted to the Grantee provided such use shall not interfere with the Facilities or with the discharge and conveyance of sewage through the Facilities, or any other rights granted to the Grantee hereunder.
