



## Response to Comments:

## Singletree Acres – Plat Review Comments 2-22-2024

Below are the response to comments to the comments that were given on Feb 22<sup>nd</sup>, 2024 for the Singletree Acres Subdivision located at 4520 West & 2200 South in Taylor, Utah.

## Weber County Survey Department – Bridger Curtis – Document Comments

- How did you determine boundary? If you're holding the points set by Reeve, what document did you use to retrace their position? The boundary doesn't match ROS #7510 prepared by Vara 3D, you will need to file this plat as a record of survey, or a new survey that agrees with this plat, if you are using this boundary. *Response*: See the attached documentation. The ROS Survey is to be recorded and matches this plat.
- 2. Lots 6&7 don't close. Easterly dimensions need to be updated to account for new ROW width. *Response*: See the revised plat.
- 3. Show dimensions. *Response*: See the revised plat.
- Missing distances. Response: See the revised plat
- 5. Acreage of lots needs to be shown. *Response*: See the revised plat
- SD easement will need to be dedicated separately from the public utility easements. Who will be maintaining it? *Response*: See the revised plat
- 7. Show acreage/sq ft of dedication. *Response*: See the revised plat.
- Remove this line. *Response*: Line has been removed. See the revised plat.
- 9. Please label and dimension if this is a street. The South line should be parallel to the boundary.

Response: See the revised plat.

- 10. Show dimensions. *Response*: See the revised plat.
- Turnaround easement needs to be clearly dimensioned and tied to the boundary, centerline or lot. L2 is mislabelled. *Response*: See the revised plat.
- 12. East/West bearings incorrect on Lots 13 thru 19. *Response*: These have been fixed. See the revised plat.
- 13. Check bearing and distances on all lots. *Response*: See the revised plat.
- 14. Pathway easement needs to be dedicated. *Response*: See the revised plat.
- 15. Check East/West Bearings on Lots 21 thru 25. *Response*: See the revised plat.
- 16. Please add no access line along 2200 S for Lots 1&2. *Response*: See the revised plat.
- 17. Missing distance. *Response*: See the revised plat.
- 18. Street width needs to be consistent; bearings need to be parallel, distance of 91.26' doesn't work.

Response: See the revised plat.

- 19. Notes:
  - 1. Lot corners and centerline monuments need to be shown as set
  - 2. Final document needs to be 24X36
  - 3. Addresses will be assigned once redlines are fixed
  - 4. This is a preliminary review. There may be additional redlines on the following submittal *Response*: Noted.
