



**SCHEDULE B - Section 1
Requirements**

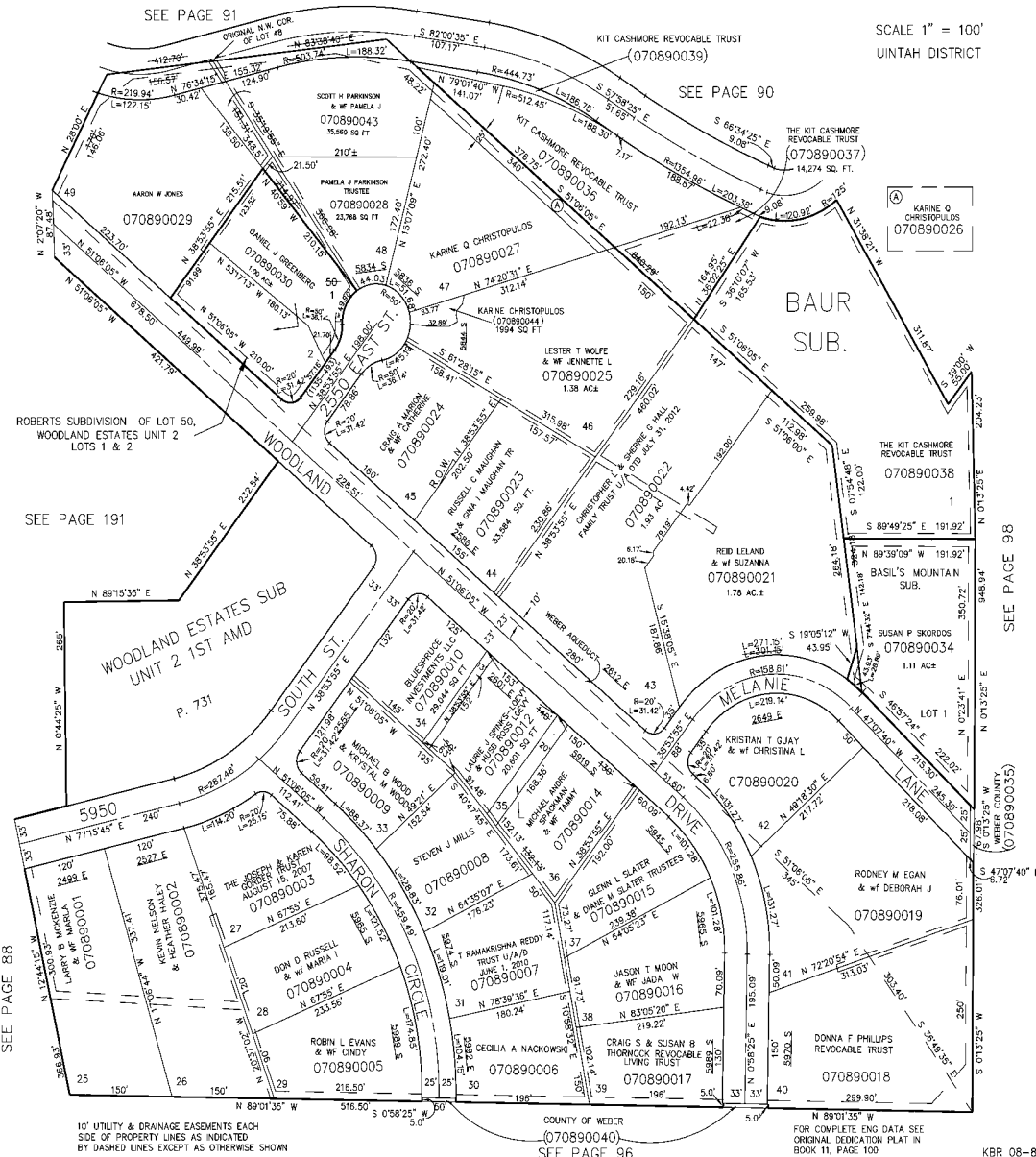

CONDITIONS
