The Ogden Valley Planning Commission approved this public utility substation for the Green Hill Country Estates Cluster Subdivision Water Treatment Plant in a public meeting held on November 19, 2024, with the following conditions: 1) Public drinking water system requirements are satisfied

2) The site, structure, and mechanical equipment shall be kept and maintained for safety and good visual appearance3) Service and delivery vehicle parking is prohibited within the private right-of-way.

The approved plans display compliance with the minimum yard setbacks of 20' on the front and rear, 8' on the sides.
