

- ☒ The application shall include a Storm Water Pollution Prevention Plan which meets the criteria set forth in Section 40-3-4 of the county ordinances.

The applicant shall file the application on or before the following dates:

Subdivision: The date that the applicant submits the preliminary subdivision development plat application.

Site Plan: The date that the applicant submits a site plan application or amended site plan.

Building Permit: The date that the applicant submits a building permit application if the applicant proposes to construct a building on an existing lot or parcel.

Land Use Permit: The date that the applicant submits a land use permit application.

Other: At least two (2) weeks before the developer intends to perform any type of work not listed above that would require a Storm Water Construction Activity Permit pursuant to this Chapter.

Failure to acquire a required Storm Water Construction Activity Permit is grounds for tabling a related subdivision application, site plan application, conditional use permit application, or building permit application. It is unlawful to commence work (move dirt) on a development site before obtaining a required Storm Water Construction Activity Permit.

Note: A pre-construction meeting is required before performing any on-site earth work, unless waived by the county engineer.

Co-Permittee

Any party performing construction activity at the facility or site described in the application. The name of the operator may be the developer, owner, general contractor, design firm, the excavation contractor and/or others.

Card Verification Value

The card security code (CSC) is a 3- or 4- digit number which is not part of the credit card number. The number appears only on the credit card itself (not on receipts or statements), so provides some assurance that the physical card is in the possession of the buyer. This reduces the chance of fraudulent card use.

For Visa, MasterCard, and Discover Card, the code is the last 3 digits of the number printed on the back of the credit card in the signature field. For American Express, it is the 4 digit number printed on the right side above the imprinted card number on the front of the credit card.
