
THE PURPOSE OF THIS PLAT IS TO DIVIDE THE BELOW DESCRIBED PROPERTY INTO 3 LOTS AS SHOWN. THE BOUNDARY WAS DETERMINED BY THE LOCATION OF WOODLAND ESTATES SUBDIVISION UNIT 1, RAINTREE SUBDIVISION NO 2 AND RAINTREE SUBDIVISION NO 3, AND MICHAEL BELL SUBDIVISION.
