NARRATIVE

This survey was requested by Mr. Colin Murphy for the purpose of acquiring a portion of Lot 7 that he had been occupying.

A Brass Cap Monument was found at the Southwest Corner of Section 24, T5N, R1W, SLB&M, U.S. Survey, a Rebar & Cap was found at the Southwest Corner of Lot 3 of Spring Creek Estates Subdivision No. 2. These monuments were the used as evidence of the original survey and location and ground location and their locations were honored.

A line bearing South 54°13'43" East between the Southwest Corner of Section 26 and the Southwest corner of Lot 3 was used as the basis of bearings. This bearing was calculated from the original subdivision plat recorded as Entry #1057482.

Record bearings can be rotated clockwise 0°36'44", to match Weber County Surveyor State Plane Grid bearings.

Property corners were monumented as depicted on this drawing.
