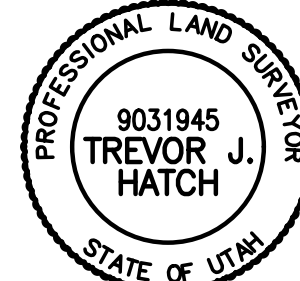
THE PURPOSE OF THIS PLAT IS TO DIVIDE THIS PROPERTY INTO LOTS. NORTH LINE WAS HELD AT RECORD OF 1320 FROM THE NORTH LINE OF THE QUARTER. THE EAST LINE WAS HELD TO THE EAST LINE OF THE QUARTER. THE SOUTH LINE FOLLOWS AN EXISTING LONG ESTABLISHED FENCE LINE. THE WEST IS HELD TO THE CENTERLINE OF NORTH RIVER DRIVE. ALL BOUNDARY CORNERS AND REAR LOT CORNERS WERE SET WITH A 3/8" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES". ALL FRONT LOT CORNERS WERE SET WITH A LEAD PLUG IN THE TOP BACK OF CURB AT THE EXTENSION OF THE SIDE LOT LINES.

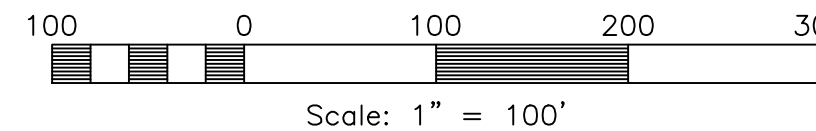

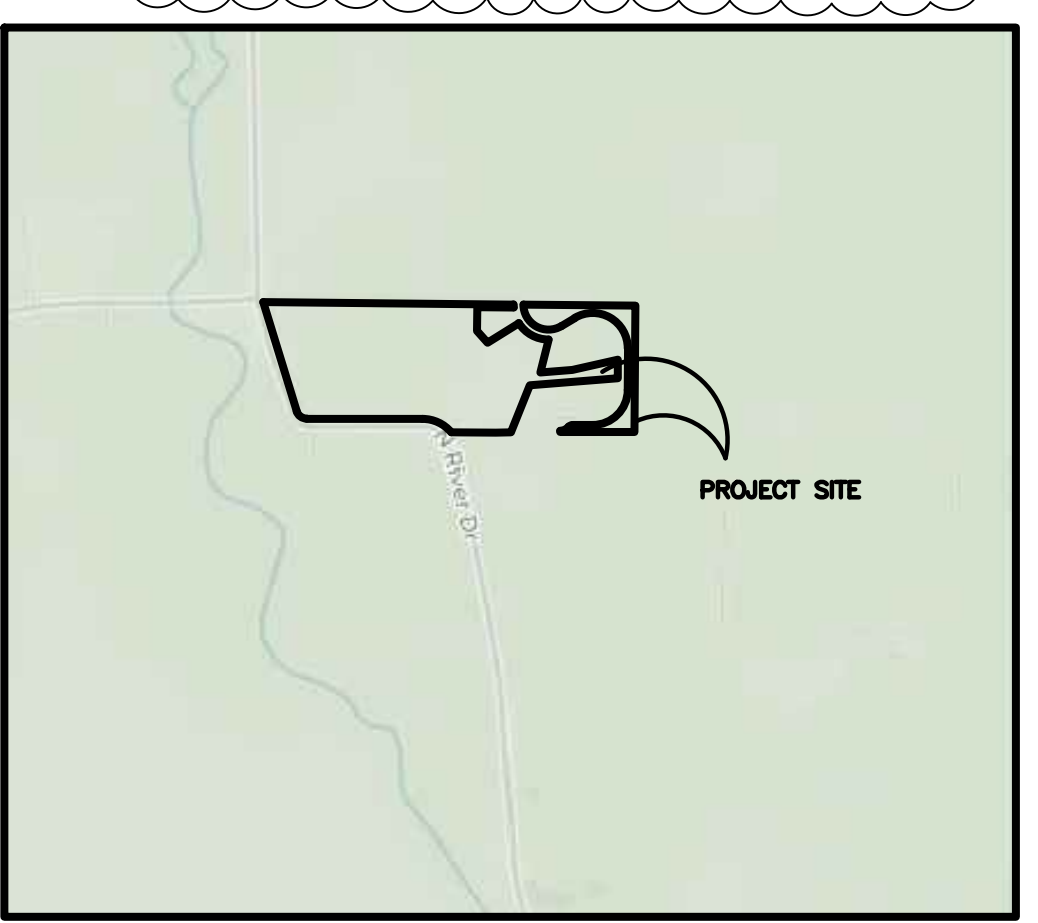
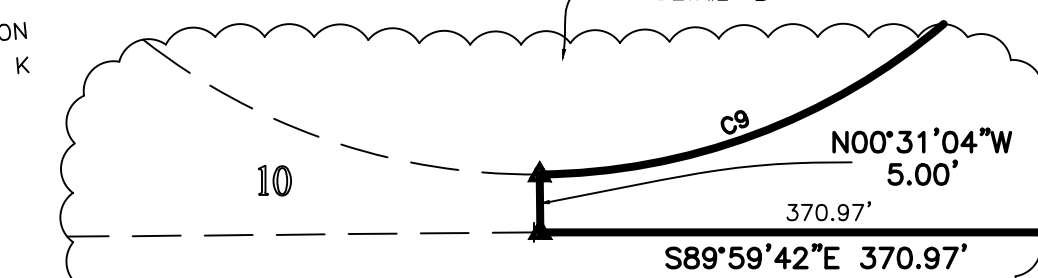
