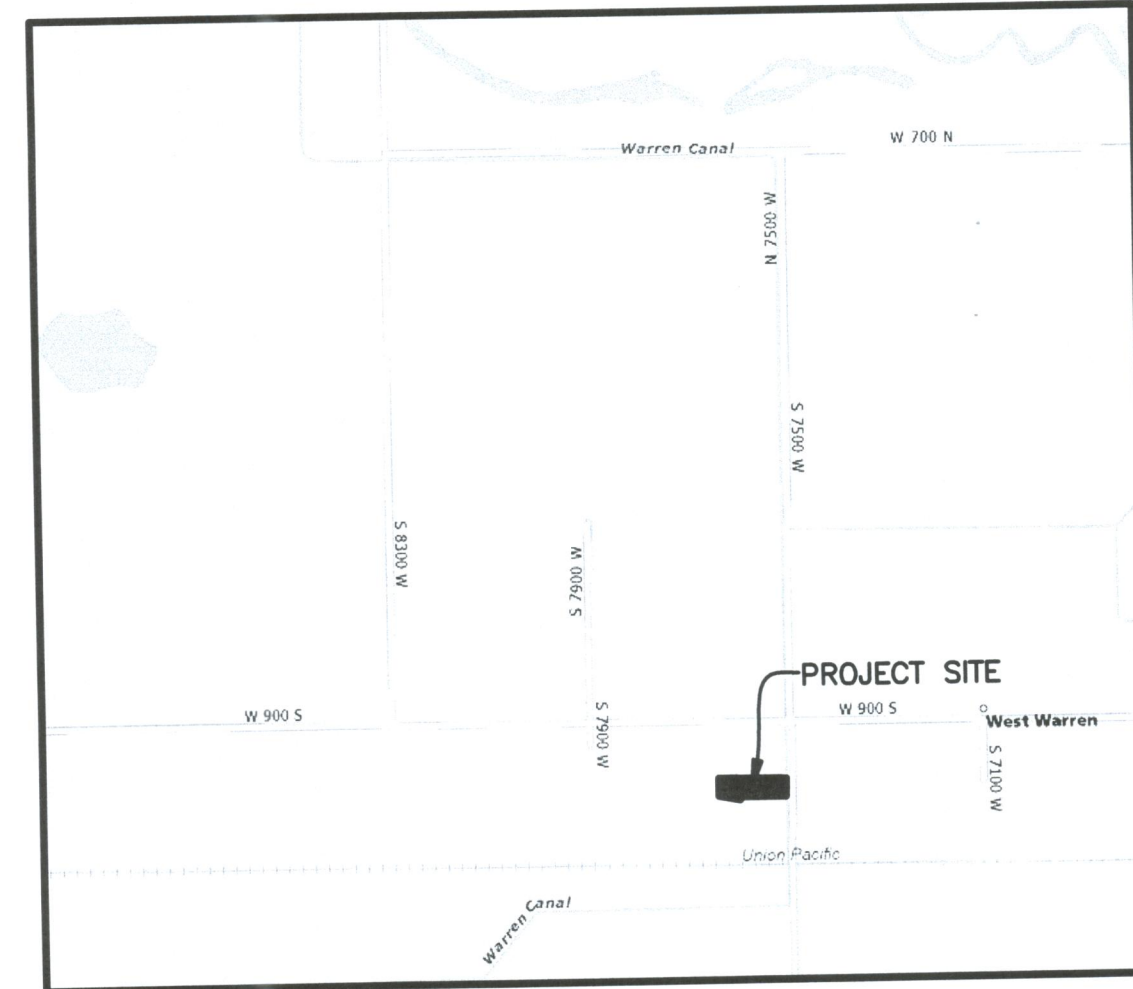

BASIS OF BEARINGS

THE BASIS OF BEARINGS FOR THIS PLAT IS THE SECTION LINE BETWEEN THE SOUTHEAST CORNER AND THE WITNESS MONUMENT FOR THE EAST QUARTER CORNER OF SECTION 22, TOWNSHIP 6 NORTH, RANGE 3 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, SHOWN HEREON AS S00°59'35"W (2640.16') (VERIFY DIST)

NARRATIVE

THE PURPOSE OF THIS PLAT IS TO CREATE A ONE LOT SUBDIVISION OF THE BELOW DESCRIBED PARCEL OF LAND. ALL BOUNDARY CORNERS WERE SET WITH A 5/8" REBAR AND PLASTIC CAP STAMPED "REEVE & ASSOCIATES".

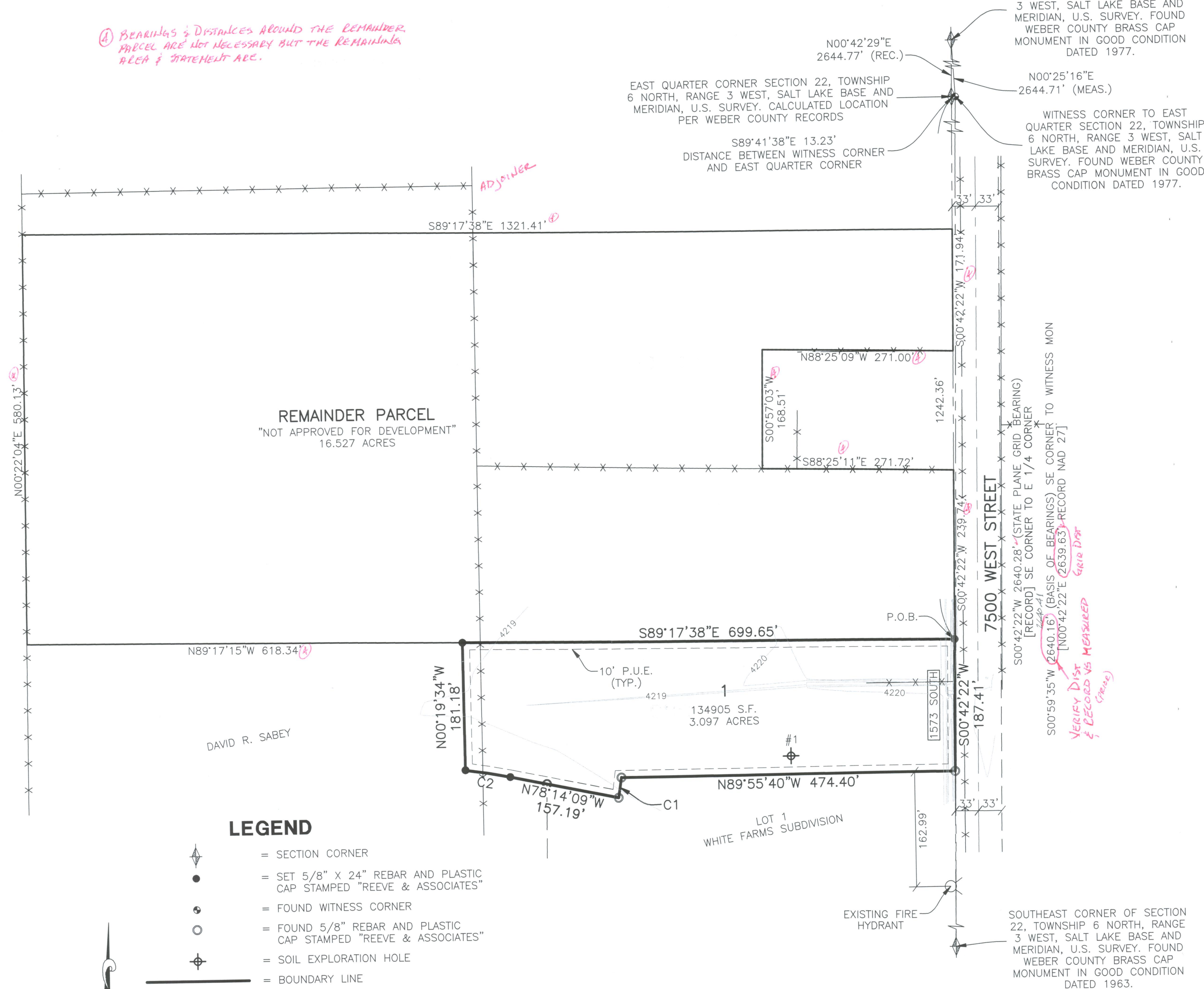
BOUNDARY DESCRIPTION

A PART OF THE SOUTHEAST QUARTER OF SECTION 22, TOWNSHIP 6 NORTH, RANGE 3 WEST, SALT LAKE BASE AND MERIDIAN, U.S. SURVEY, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE WEST RIGHT-OF-WAY LINE OF 7500 WEST STREET, SAID POINT ALSO BEING S00°42'22"W 1242.36 FEET FROM THE EAST QUARTER CORNER OF SECTION 22; THENCE S00°42'22"W 187.41 FEET TO THE NORTH LINE OF WHITE FARMS SUBDIVISION; THENCE ALONG SAID NORTH LINE THE FOLLOWING FOUR (4) COURSES: (1) N89°55'40"W 474.40 FEET; (2) ALONG A CURVE TURNING TO THE RIGHT WITH AN ARC LENGTH OF 28.82 FEET, A RADIUS OF 830.01 FEET, A CHORD BEARING OF S08°42'28"W, AND A CHORD LENGTH OF 28.81 FEET; (3) N78°14'09"W 157.19 FEET; AND (4) ALONG A CURVE TURNING TO THE LEFT WITH AN ARC LENGTH OF 64.50 FEET, A RADIUS OF 825.00 FEET, A CHORD BEARING OF N80°28'32"W, AND A CHORD LENGTH OF 64.49 FEET; THENCE N00°19'34"W 181.18 FEET; THENCE S89°17'38"E 699.65 FEET TO THE POINT OF BEGINNING.

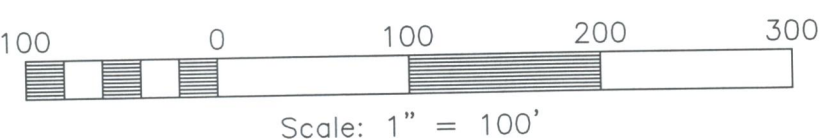
