- 1) The area that will be disturbed will be approximately 20% more than the footprint of the home, which is approximately 2200 Sq Ft.
- 2) The contractor, Art Pluim Construction, will be responsible for the conditions of the site during construction 801-686-2326
- 3) The neighbors will not be effected by the proposed construction activities because all erosion/run off will be contained on the proposed construction property
- 4) All excavated material will be kept on the property during temporary and permanent design
- 5) The concrete washout site will be located to the south of the home and will be a depressed area lined with plastic. Upon curing/hardening, it will be disposed of with other construction debris, as per code.
- 6) The porta-john will be installed on the south east area of the property, away from neighbors to reduce odor concerns, and will be maintained through service contract.
- 7) The construction entrance will be the existing private gravel road that will shake all loose debris from any trucks carrying mud/dust.
- 8) On the rare occasion that any mud/or dirt gets on the asphalt it will be removed with equipment and brooms within hours, just as quickly as the motorcycle track one mile away removes all dust and dirt from the asphalt, on a weekly basis during the summer months.
- 9) There is a swell on 4000 to the north of the construction site, and it will be protected by not getting any dirt on the asphalt. This will protect the swell. Also any excavated material will not be deposited in close proximity to the swell thus being unable to run off into the swell.
- 10) The rain/storm waters currently get absorbed into the ground and provide moisture to the vegetation.
- 11) There is no current occupation on the property
