Here are the written responses you requested.

1. We received sheets with the detention ponds enlarged, but there still appears to be some missing information. Please refer to the PDF for the specific comments. **Added the required notes and changes to the drawings.**
2. See the attached pdfs for additional comments. **(Sheet 1 & 2 of the PDF file did not have any redlines?)**
  1. Road sections not updated. **(Revised the Road sections.)**
  2. Planter depth not defined. **(The planter depth is shown in the profile. The planter depth is determined by the maximum wall height - west wall 12' max. east wall 9' max. The planter box can vary in height as needed to reduce the overall retaining wall height to be less than the max specified. The planter box maximum height required to reduce the overall wall height is less than 3 feet tall.)**
3. When all items are addressed I will need stamped sheets of the changed pages sheets 2,3,10/10 and 1/1 of the detention basin x-sections. **(Final stamped drawings were submitted.)**
