
Comments

A geologic hazards assessment has been performed and a report has been prepared by IGES dated January 16, 2017, identified as Project #01628-022. All site development will need to adhere to the geologic and geotechnical recommendations in the report. IGES engineering geologist and geotechnical engineer must observe the foundation excavation for the proposed townhome to confirm the absence of adverse geologic conditions in the area. Prior to issuing the Certificate of Occupancy, Weber County will record a "Notice of Natural Hazards Disclosure" against the property for future property owners information.
