

Final approval of that onsite wastewater treatment system (septic system) was granted in September of 1979 after the appropriate inspection where performed by staff of the Weber-Morgan Health Department.

If the residence has been maintained in its original state, no increase in daily wastewater generation would be expected thus no additional permitting or approval would be required by our office to allow the continued use of the residence in its current state.

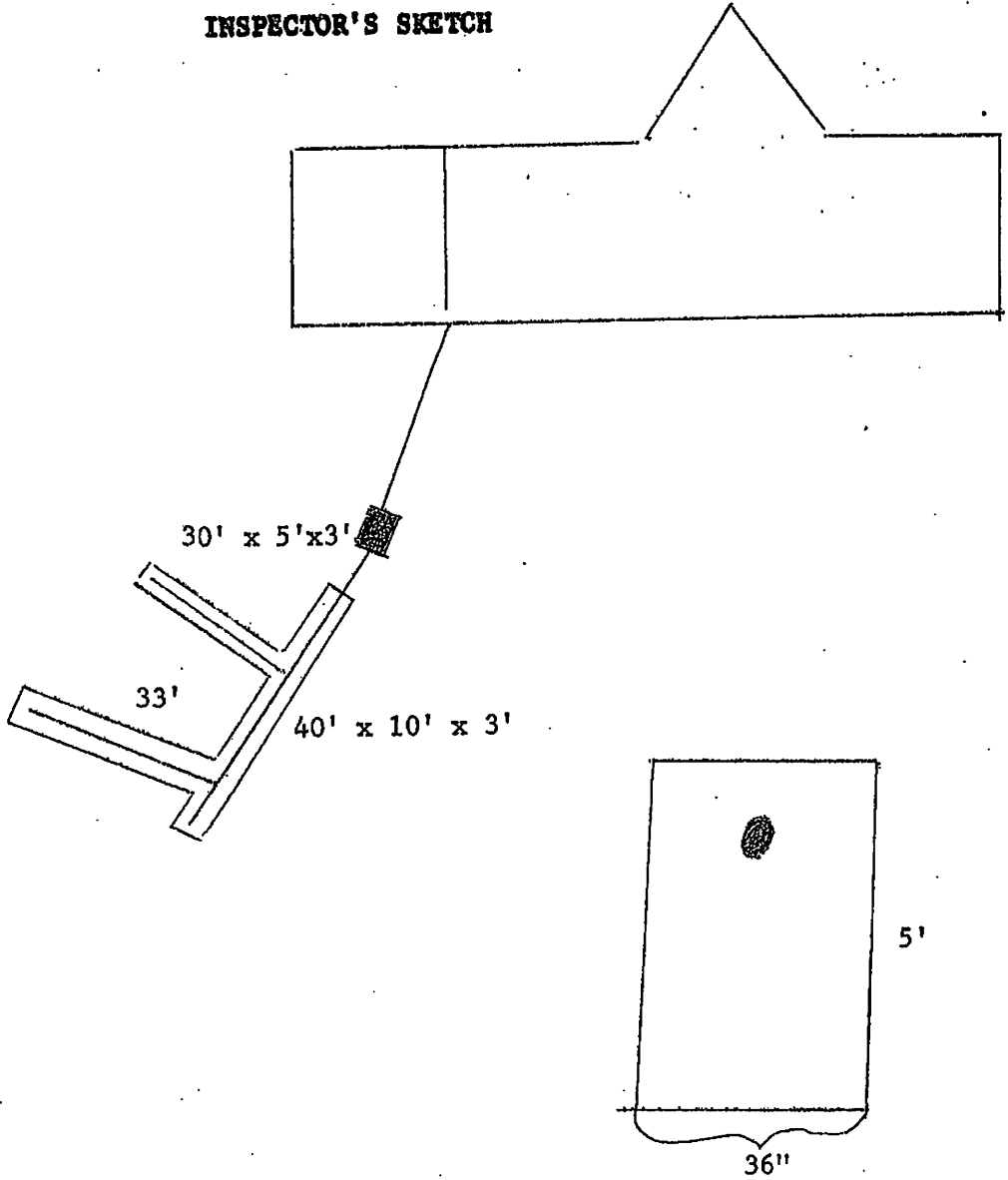
