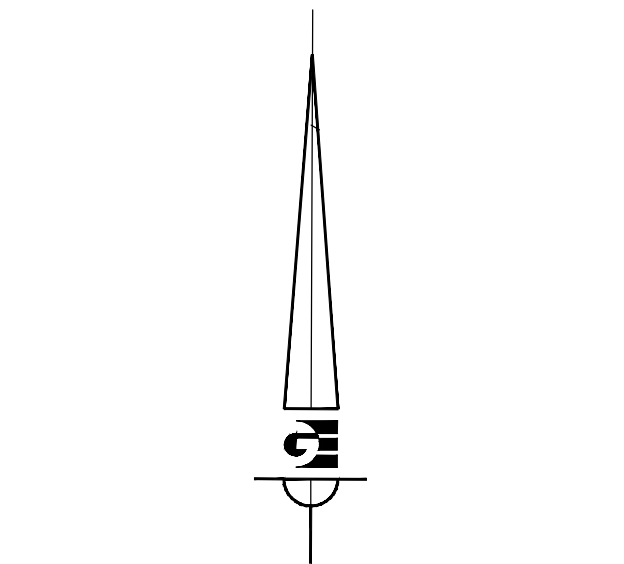
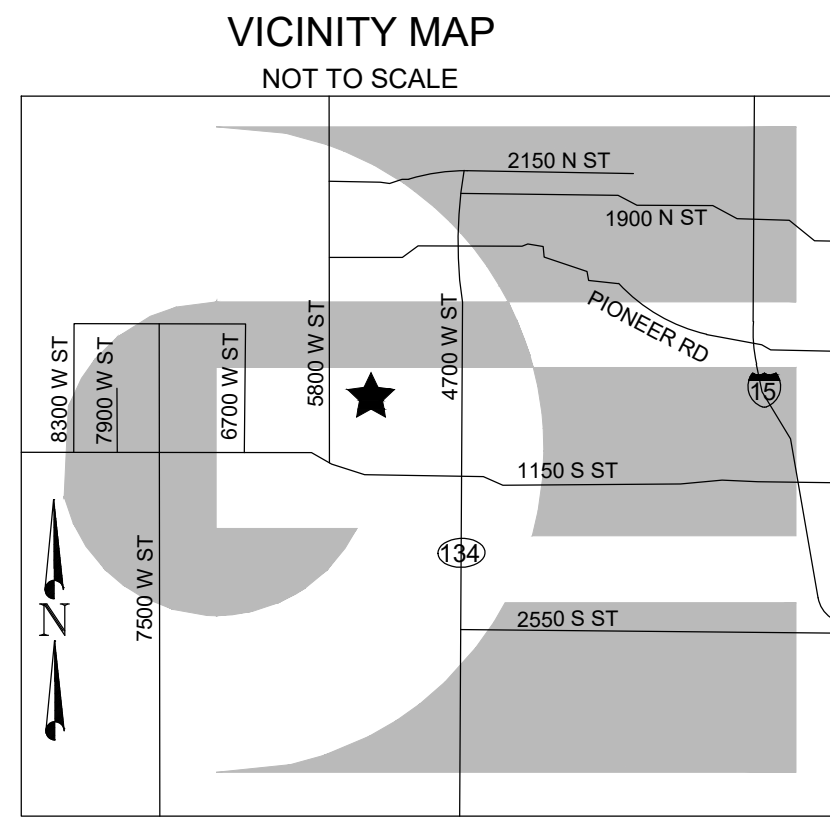

BOUNDARY DESCRIPTION

A PART OF THE NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 6 NORTH, RANGE 3 WEST OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE SOUTHWEST CORNER OF LOT 1, LOCATED NORTH 0°29'13" EAST 1321.54 FEET ALONG THE WEST SECTION LINE OF SAID SECTION 15 AND NORTH 90°00'00" WEST 643.08 FEET FROM THE SOUTHWEST QUARTER CORNER; RUNNING THENCE NORTH 0°35'06" EAST 740.40 FEET; THENCE SOUTH 89°24'54" EAST 296.20 FEET; THENCE SOUTH 0°47'12" WEST 740.40 FEET; THENCE NORTH 89°12'48" 295.16 FEET TO THE POINT OF BEGINNING. CONTAINS 5.01 ACRES.

THE PURPOSE OF THIS SURVEY WAS TO CREATE A ONE LOT SUBDIVISION ON THE PROPERTY AS SHOWN AND DESCRIBED HEREON. THE SURVEY WAS ORDERED BY JOHN PRICE. THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION AS SHOWN AND NOTED HEREON. THE BASIS OF BEARING IS THE WEST LINE OF THE NORTHEAST QUARTER OF SECTION 15, TOWNSHIP 6 NORTH, RANGE 3 WEST, OF THE SALT LAKE BASE AND MERIDIAN WHICH BEARS NORTH 0°29'13" EAST WEBER COUNTY, UTAH NORTH, NAD 83 STATE PLANE GRID BEARING. RECORDED SURVEYS AND SUBDIVISION PLATS WITHIN SAID SECTION WERE USED TO DETERMINE THE BOUNDARY.

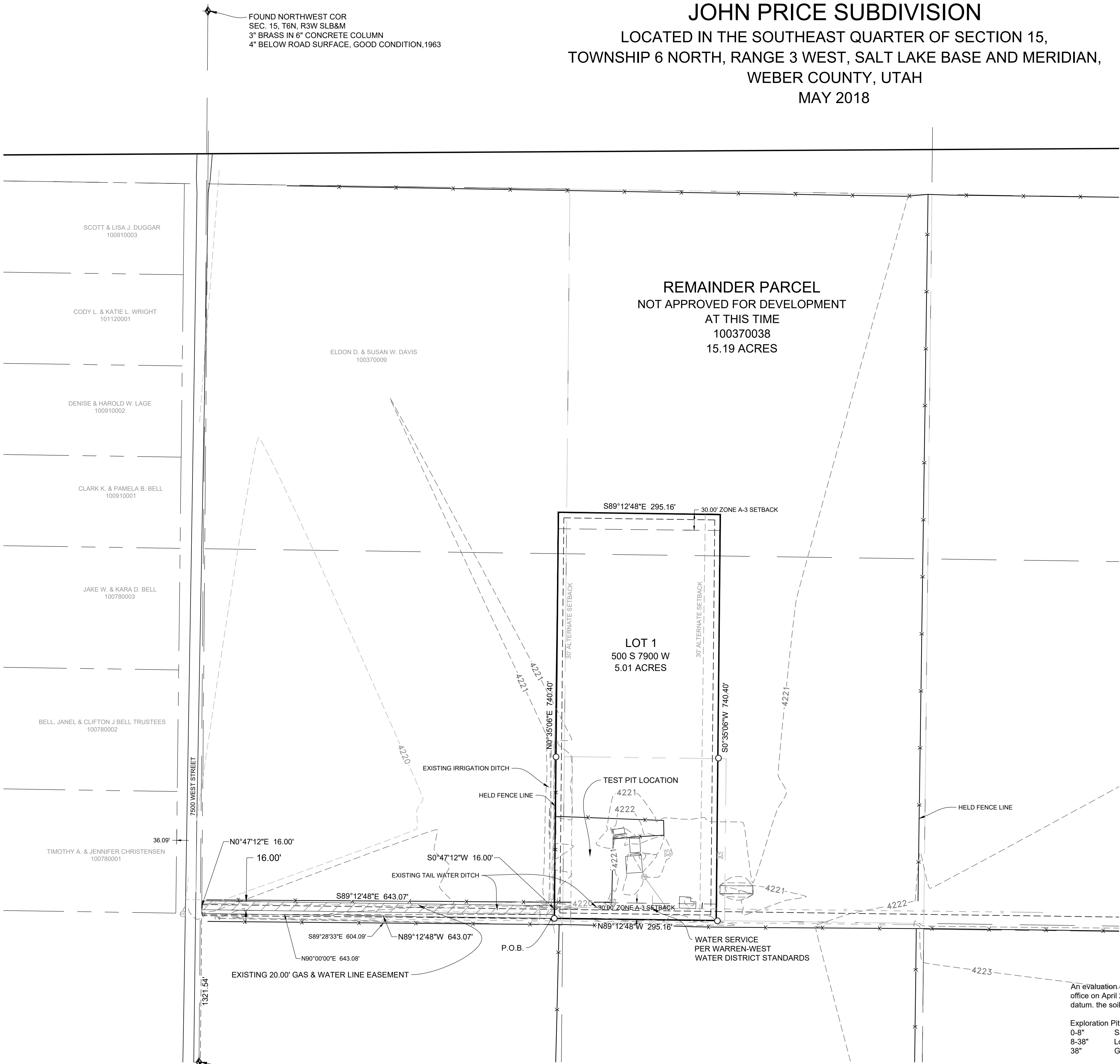
