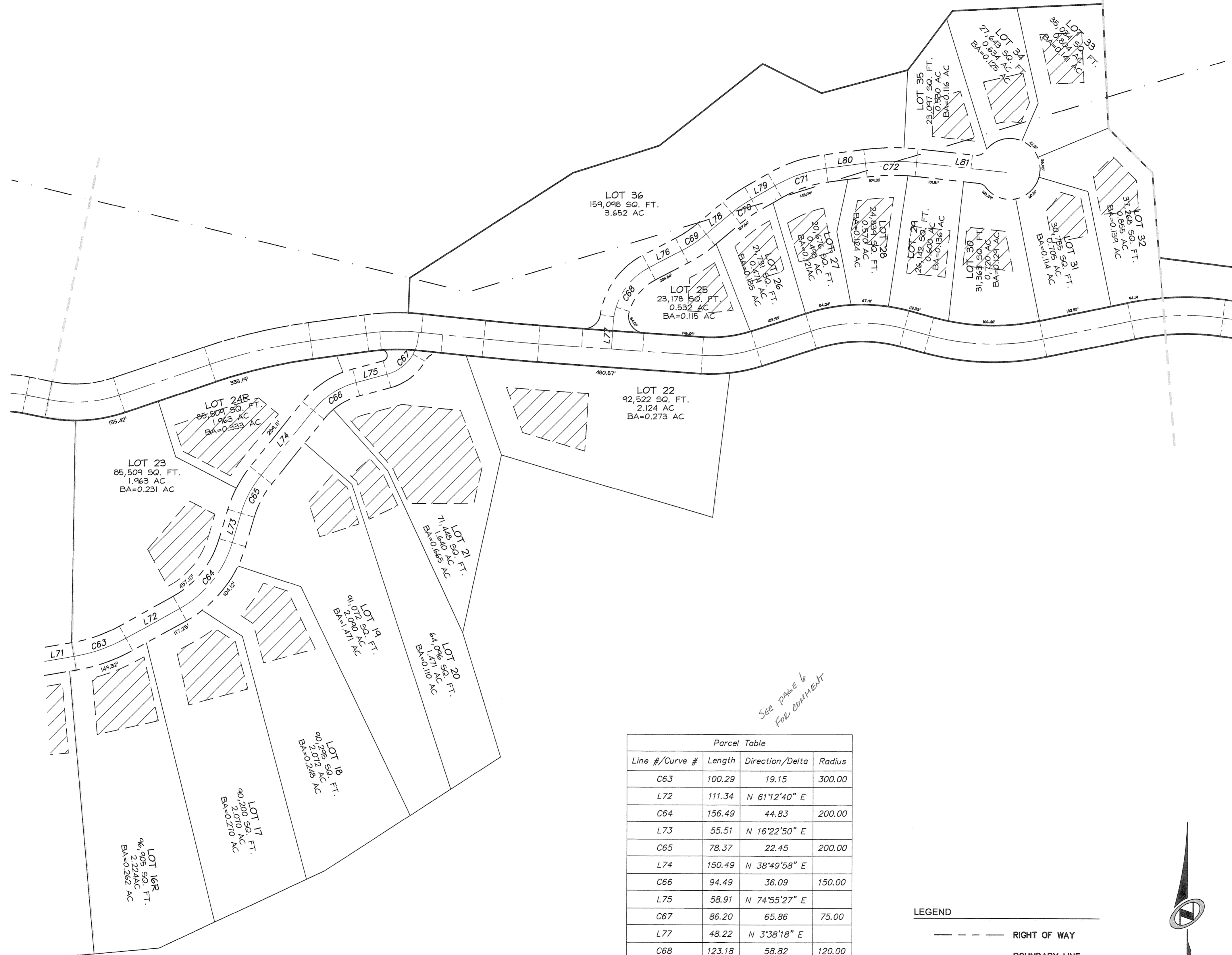


# SUMMIT AT POWDER MOUNTAIN PHASE I

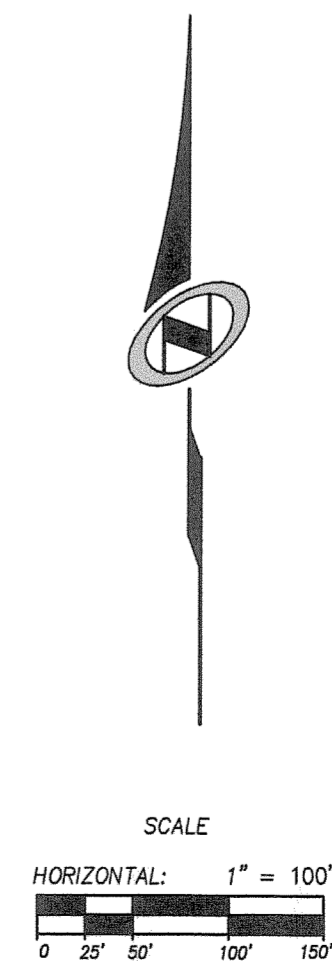
