
The side setbacks may be further reduced to 3' and the height may increase to 35' IF the structure remains at least 100' from the front property line and also maintains a separation of at least 40' from a dwelling on an adjacent lot.

Per the Western Weber Planning Commission design review approval on 07/14/2020, the structure must have a single uniform color on all four facades.
