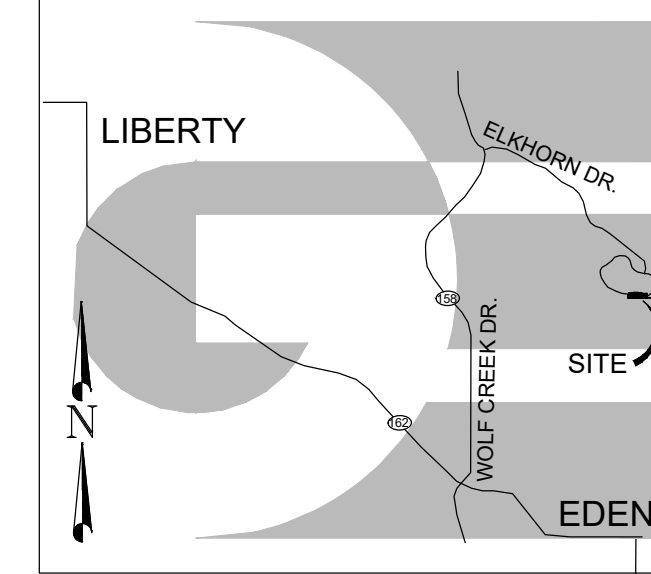


TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 7C

BOUNDARY DESCRIPTION

A PART OF THE NORTHWEST QUARTER OF SECTION 26, TOWNSHIP 7 NORTH, RANGE 1 EAST OF THE SALT LAKE BASE AND MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT ON THE NORTHERLY RIGHT-OF-WAY LINE OF BIGHORN PARKWAY, SAID POINT ALSO BEING THE NORTHEAST CORNER OF TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 7A, BEING LOCATED SOUTH 0°27'53" WEST 1141.15 FEET AND NORTH 90°00'00" EAST 1519.20 FEET AND ALONG THE ARC OF A CURVE TO THE LEFT 64.15 FEET, HAVING A RADIUS OF 270.00 FEET, A CENTRAL ANGLE OF 13°36'49", AND WHICH CHORD BEARS NORTH 87°38'45" EAST 64.00 FEET AND NORTH 80°50'21" EAST 40.13 FEET AND ALONG THE ARC OF A CURVE TO THE RIGHT 212.75 FEET, HAVING A RADIUS OF 930.00 FEET, A CENTRAL ANGLE OF 13°06'28", AND WHICH CHORD BEARS NORTH 87°23'33" EAST 212.29 FEET, RUNNING THENCE ALONG THE ARC OF A 930.00 FOOT RADIUS CURVE TO THE RIGHT 141.29 FEET, HAVING A CENTRAL ANGLE OF 08°42'16", CHORD BEARS SOUTH 81°42'08" EAST 141.15 FEET; THENCE SOUTH 77°20'58" EAST 30.68 FEET; THENCE ALONG THE ARC OF A 270.00 FOOT RADIUS CURVE TO THE LEFT, HAVING A CENTRAL ANGLE OF 12°39'02", CHORD BEARS SOUTH 83°40'29" EAST 59.49 FEET; THENCE NORTH 90°00'00" EAST 85.56 FEET; THENCE ALONG THE ARC OF A 170.00 FOOT RADIUS CURVE TO THE LEFT 49.75 FEET, HAVING A CENTRAL ANGLE OF 16°46'08", CHORD BEARS NORTH 81°36'59" EAST 49.58 FEET TO A POINT ON THE WEST BOUNDARY LINE OF SAID TRAPPERS RIDGE AT WOLF CREEK P.R.U.D. PHASE 3; THENCE ALONG THE BOUNDARY LINE OF SAID PHASE 3 THE FOLLOWING TWO (2) COURSES: (1) SOUTH 04°37'00" EAST 173.35 FEET; (2) SOUTH 89°48'08" EAST 432.86 FEET TO THE EAST LINE OF SAID NORTHWEST QUARTER; THENCE ALONG THE EAST LINE OF SAID NORTHWEST QUARTER SOUTH 00°21'52" WEST 12.00 FEET; THENCE NORTH 89°48'08" WEST 824.35 FEET TO THE SOUTHEAST CORNER OF SAID PHASE 7A; THENCE ALONG THE EAST BOUNDARY LINE OF SAID PHASE 7A THE FOLLOWING THREE COURSES: (1) NORTH 00°00'00" EAST 13.76 FEET; (2) ALONG THE ARC OF A 1030.00 FOOT RADIUS CURVE TO THE RIGHT 100.44 FEET, HAVING A CENTRAL ANGLE OF 05°35'14", CHORD BEARS NORTH 02°47'37" EAST 100.40 FEET; (3) NORTH 05°35'14" EAST 96.27 FEET TO THE POINT OF BEGINNING. CONTAINING 76,406 SQUARE FEET OR 1.754 ACRES.

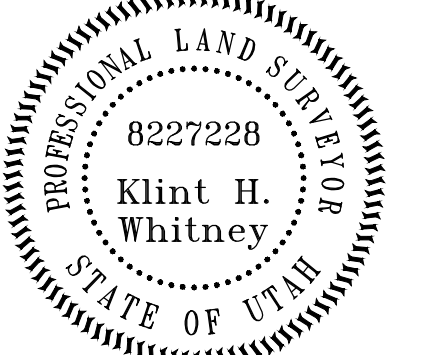

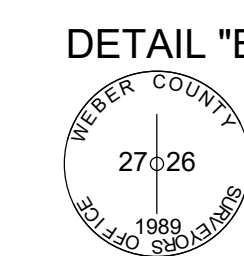
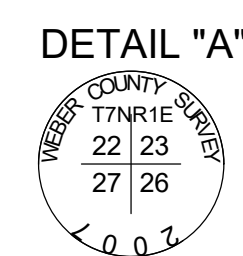

THE CONTROL USED TO ESTABLISH THE BOUNDARY WAS THE EXISTING WEBER COUNTY SURVEY MONUMENTATION AS SHOWN AND NOTED HEREON AND THE EXISTING MONUMENTATION FROM PREVIOUS PHASES OF THE TRAPPERS RIDGE DEVELOPMENT AS SHOWN AND NOTED HEREON. WARRANTY DEED RECORDED AS ENTRY NUMBER 2107754 AND DEDICATED PLATS OF PREVIOUS PHASES OF TRAPPERS RIDGE ALONG WITH OTHER DOCUMENT WE USED TO DETERMINE THE BOUNDARY. 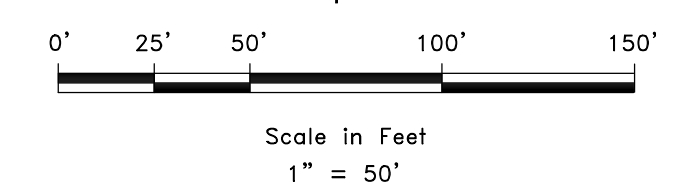
