MEMORANDUM OF UNDERSTANDING BETWEEN WEBER FIRE DISTRICT AND RACEDAY EVENT MANAGEMENT

This MEMORANDUM OF UNDERSTANDING is hereby made and entered into by and between the Weber Fire District, hereinafter referred to as the District, and RaceDay Event Management, hereinafter referred to as RaceDay.

A. PURPOSE:

The purpose of this MOU is to establish an agreement and understanding regarding the provision of medical personnel and equipment for the Utah State Hill Climb Series event scheduled for June 26, 2021 at the Old SnowBasin Rd.

B. DISTRICT SHALL:

- Saturday, June 26, 2021: (0830 until released): Provide two (2) medical personnel at the Advanced-EMT (AEMT) level to provide onsite emergency medical response. These personnel shall staff one (1) Side by Side with medical gear (this unit will be dedicated to the event and not leave).
- Provide any equipment necessary to afford onsite emergency medical response, in performance of this agreement, which is outside of any onsite medical provided by RaceDay.

C. RACEDAY SHALL:

- Provide logistical support, including:
 - o Course Maps;
 - o Incident Action Plan (IAP) and/or other necessary plans;
 - o Any further directions needed for onsite crews to perform their duties.
- Compensate the Weber Fire District for the provision of personnel and equipment, at the following schedule:
 - o June 26, 2021: One staffed AEMT Medical Side by Side at \$110.00/hr.
- D. IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT: Upon acceptance of the terms of this MOU, the District shall provide personnel and equipment as specified in this MOU, and that RaceDay shall carry out the terms of this MOU and, upon within 30 days of receipt of satisfactory statements of expenditures in accordance with the schedule listed in Part C, reimburse the District for said schedule.
