## Ogden Valley Planning Commission NOTICE OF DECISION

You are hereby notified that your CUP application for a <u>water tank</u>, <u>well</u>, and <u>pump house</u> at <u>Powder Mountain</u> was heard by the Ogden Valley Township Planning Commission in a public meeting held on July 30, 2013 after due notice to the general public.

The Ogden Valley Township Planning Commission found that sufficient evidence was presented to establish:

- 1. Reasonably anticipated detrimental effects of a proposed conditional use can be substantially mitigated by the proposal or by the imposition of reasonable conditions to achieve compliance with applicable standards. Examples of potential negative impacts are odor, vibration, light, dust, smoke, or noise.
- 2. That the proposed use will comply with the regulations and conditions specified in the Zoning Ordinance and other applicable agency standards for such use.
- 1. The water tank will be buried and revegetated with native grass seeds. Any piping that is visible from the site will be visible from the road located below the tank. The well house will be painted a brown color. Access to the water tank, well, and pump house are from existing dirt roads.
- 2. The proposed water tank, well, and pump house will comply with all applicable land use codes.

Therefore, the Ogden Valley Township Planning Commission renders the following decision:
