 1. ALL EXISTING UTILITIES SHALL BE SHOWN ON THE SITE PLAN. THE CONTRACTOR SHALL VERIFY THE LOCATION AND DEPTH OF ALL UTILITIES PRIOR TO CONSTRUCTION. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS AND APPROVALS FROM THE APPROPRIATE AGENCIES.
 2. ALL CONSTRUCTION SHALL BE IN ACCORDANCE WITH THE UTAH CONSTRUCTION STANDARDS AND SPECIFICATIONS. THE CONTRACTOR SHALL MAINTAIN ACCESS TO ALL ADJACENT PROPERTIES AND PUBLIC ROADS AT ALL TIMES.
 3. ALL MATERIALS AND METHODS SHALL BE APPROVED BY THE ENGINEER PRIOR TO CONSTRUCTION.
 4. THE CONTRACTOR SHALL MAINTAIN RECORDS OF ALL CONSTRUCTION ACTIVITIES AND SUBMIT THEM TO THE ENGINEER UPON COMPLETION OF THE PROJECT.
 5. ALL UTILITIES SHALL BE PROTECTED AND SHALL NOT BE DEGRADED OR DAMAGED. IF ANY UTILITIES ARE DAMAGED, THE CONTRACTOR SHALL BE RESPONSIBLE FOR REPAIRING THEM AT HIS OWN EXPENSE.
 6. THE CONTRACTOR SHALL MAINTAIN THE SITE IN A SAFE AND SOUND MANNER AT ALL TIMES. ALL EXCESS MATERIALS SHALL BE REMOVED FROM THE SITE.
 7. ALL CONSTRUCTION SHALL BE COMPLETED WITHIN THE SPECIFIED TIME FRAME.
