Dear USATF Sanction holders and Insurance Certificate holders:

As the National Governing Body for track and field, long-distance running and race walking in the United States, USA Track & Field (USATF) provides sanctions which approve and license the hosting of competitive track & field, long distance running and race walking events in the United States. As part of sanctioning, USATF provides Commercial General Liability insurance coverage for the protection and benefit of its active member clubs, associations, event organizers, facility owners and individual members in connection with sanctioned events.

The current USATF General Liability program is scheduled to expire on 11/1/2022. In August we will begin the process of renewing the program for another annual term effective 11/01/2022-11/1/2023. The program will seek to provide similar limits to the expiring policies as follows:

Excess coverage of \$10,000,000 is available for third parties who require additional coverage.

We expect to finalize the renewal by October, and will immediately begin issuing certificates for those USATF sanctioned events taking place in the month of November and beyond.

Hi Eric,

Congratulations! The USATF event sanction application for the Winter Training Series Half Marathon on 04/01/2023 has been reviewed and approved by the USATF National Office.

As a Reminder: All sanctioned events must abide all USATF Rules and Regulations. If a sanctioned event fails to abide by USATF Rules and Regulations, USATF may impose a deductible against the event organizer and/or organization for any claim incurred against the sanctioned event. A deductible amount of \$2,500 may be assessed for the first offense by the event organizer and/or organization. A deductible amount of \$5,000 may be assessed for the second offense by the event organizer and/or organization. A deductible amount of \$10,000 may be assessed for the third offense by the event organizer and/or organization. Additionally, following the third offense by the event organizer and/or organization, USATF may refuse to sanction any future events for the event director and/or organization. Offenses will be attributed to the event organizer and/or organization irrespective of the sanctioned event involved; therefore, offenses will be cumulative and do not need to be of the same type or need to occur all within the same sanctioned event.

USATF sanctioned events must not include man-made obstacles, mudpits, or any other hazardous obstacles (note: regulation hurdles and steeplechase barriers used for track & fields competition do not apply)

USATF sanctioned event policy does not allow for animals to participate in competitions.

USATF sanctioned events must require all participants, officials and volunteers to sign the <u>USATF waiver of liability</u> that releases the race organizers, volunteers and officials, and USAT from claims for damages. All waivers will be maintained in a secure location for at least ten years (or longer if your states statue of limitations on liability claims is longer than ten years). The event director must be able to produce this waiver in the event of a claim against any of the named parties. If a sanctioned event incurs a claim wherein the event organizer and/or organization are unable to produce the required waiver for the participants, official or volunteer involved in the claim, the event organizer and/or organization will have a \$10,000 deductible on the claim, payable to USATF.

Your Certificate(s) of Insurance will be issued in a separate email.

Following the completion of your sanctioned event, remember to log back into USATF Connect to submit your results and post event report form within fifteen (15) days.
