PARKING USE AGREEMENT

[Prop. No. 502-3505]

THIS PARKING USE AGREEMENT ("Agreement") is entered into as of this day of April, 2023 (the "Effective Date"), by and between WEBER SCHOOL DISTRICT, a political subdivision of the State of Utah ("Weber"), and GOAL Foundation, a Utah non-profit organization ("GOAL"). Weber and Goal are sometimes referred to herein individually as a "Party," and collectively as the "Parties."

RECITALS

- A. Weber owns that certain real property located at approximately 5821 East 1900 North, Eden, Weber County, Utah, parcel number 20-131-0001 (the "Weber Property") on which Weber operates Valley Elementary School (the "School").
- B. GOAL would like to utilize the School's parking lot for a Race Event. GOAL would like to direct its guests to utilize the School's parking lot for race registration and awards ceremony at the conclusion of the race.
- C. GOAL desires to obtain a license from Weber for use of the existing parking lot on the Weber property, as such parking lot is depicted on <u>Exhibit A</u>, attached hereto and incorporated herein by this reference (the "License Area"), and Weber is willing to grant the same upon the terms and conditions set forth herein.

TERMS AND CONDITIONS

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and based upon the mutual promises and subject to the conditions set forth below, the parties agree as follows:

- 1. <u>Grant of License; Use.</u> Weber hereby grants to GOAL, including its employees, contractors, visitors, invitees and guests, a nonexclusive license (the "License") to use the License Area for the sole purpose of the Race Event described above. This License shall be limited to the uses permitted herein during the hours of 5:30am through 4:00 pm on Saturday, April 1st, 2023.
- 2. <u>Term.</u> The term of this Agreement (the "Term") shall be from 5:30am to 4:00pm on Saturday, April 1, 2023. Weber may provide GOAL with twenty (20) days prior written notice of termination of this License for any reason whatsoever, in Weber's sole and absolute discretion. Upon termination of this Agreement, GOAL shall vacate and cease to use the License Area and shall further take commercially reasonable actions to ensure its employees, contractors, visitors, invitees and guests immediately vacate and cease using the License Area.
- 3. Access. GOAL, its employees, contractors, visitors, invitees and guests shall have the right to enter upon and use the License Area solely for the purposes permitted by this Agreement. GOAL hereby acknowledges that any other access rights on, to, or over the Weber Property historically granted or available to GOAL, its employees, contractors, visitors, invitees and guests, are hereby terminated and of no further force or effect, and GOAL waives any and all prescriptive rights to the License Area and/or Weber Property.

12. <u>Miscellaneous</u>. This Agreement shall be construed in accordance with and governed by the laws of the State of Utah. This instrument constitutes the entire agreement between the parties hereto pertaining to the subject matter hereof and all prior and contemporaneous agreements, representations and understandings of the parties hereto, oral or written, are hereby superseded and merged herein. No supplement, modification or amendment of this Agreement shall be binding unless in writing and executed by the parties hereto. This Agreement may be executed in any number of counterparts, each of which shall be an original and all of which shall constitute one and the same instrument. In the event of suit to enforce this Agreement the court or other arbiter shall award costs and reasonable attorneys' fees to the prevailing party.
